**ADOPT RESOLUTION TO ESTABLISH SELF-INSURANCE FUND NO. 67**

**October 17, 2024**

**WHEREAS**, the Education Code Section 17566 provides for the establishment of a Self-Insurance Fund for the purpose of deposit and expenditure of revenues received for the purpose of Self Insurance; and

**WHEREAS**, the Governing Board has determined that there is a need to provide insurance benefits for its employees as defined by Section 53200 of the Government Code; and

**WHEREAS**, disbursements from this fund may be made for the payment of claims, administrative costs, related services, deductible insurance amounts, purchasing excess insurance, and to deposit income received from investments, and

**WHEREAS**, the Orange County Department of Education, in complying with the said code sections, has established fund 67 for this purpose; and

**WHEREAS**, the Westminster School District wishes to comply with the California Administrative and Education Code provisions and the Orange County Department of Education directives;

**NOW THEREFORE, BE IT RESOLVED** that the Governing Board authorizes the Administration to establish a Self-Insurance Fund with the County Treasurer for the purpose of accumulating and expending revenues.
