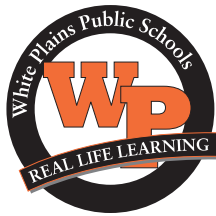

The contingency budget requires that the 2025-26 tax levy be no greater than the previous year's tax levy. Therefore, budget reductions totaling \$3,386,116 would be required, resulting in a significant impact to program offerings. In addition, further reductions would be required per law for non-contingent expenses, such as community use of the school facilities, non-health and safety maintenance projects, certain equipment, capital projects, and various administrative costs.

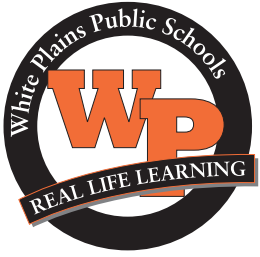

## 2025-2026 School District Budget Proposal

### Program Enhancements • Facility Upgrades • Reduced Tax Levy • No New Spending

The Annual White Plains City School District Budget Vote and School Board Election will take place on May 20, 2025, and we encourage you to participate. Your support of the White Plains City School District helps us provide excellent academic, athletics and arts opportunities for our Tigers and maintain fiscal strength. We thank you!

This year's proposed budget of \$277,965,500 reflects a fiscally conservative spending plan based on the annual update to our Long-Range Strategic Plan and Annual Budget Process, which enabled us to successfully forecast budget shortfalls, find efficiencies to close potential gaps and contend with rising costs while offering exciting, high-quality educational programming for all students.

This planning process includes comprehensive multi-year projections which, over the past eight years, have allowed us to utilize savings to fund capital projects, tax certiorari claims, employee payments for accrued leave, debt service, and one-time only expenses – thus reducing future taxpayer obligations. Along with New York State's commitment to fully fund Foundation Aid and the adoption of certain recommendations of the Rockefeller Study, the District has reduced the tax levy below the maximum allowable by law for the fifth year in a row. This year's reduction is 50%: from 3.31% to 1.67%. The Board of Education sincerely appreciates the advocacy efforts of our legislators, PTA, unit representatives, and staff.

The 2025-2026 Proposed Budget contains important instructional program enhancements and support, funded through a reallocation of resources. That is, no new money or additional spending!

#### Some highlights of plans for 2025-2026 include:

- **Elementary Schools:** Expanding Math & Movement K-1 and incorporating Math Enrichment K-5, advancement of Computer Science & Digital Fluency standards K-5, continued implementation of Science 21 & NYS Science Learning Standards 3-5 (highlighted in our previous newsletter), and using new tools to analyze and track student growth and achievement
- **Middle Schools:** Purchasing texts to enhance literacy-rich learning environments, aligning the science sequence with NYS Science Learning Standards, advancement of Computer Science & Digital Fluency Standards, developing extended day opportunities to accelerate learning, continued focus on school culture, climate and community-building, and a comprehensive review of master schedules
- **High Schools:** Adding new options to the science course sequence, continuing to shift content and instructional practices for new Regents exams, increasing the number of students earning the Seal

of Biliteracy and/or the Seal of Civic Readiness, advancement of Computer Science & Digital Fluency Standards, and shifting professional learning support to design instructional plans with intentional focus on fostering executive functioning skills and promoting student engagement

- Introduction to Robotics I, grades 9-12
- Introduction to Dance, grades 9-12
- Intermediate Ceramics (restructuring), grades 9-12
- Climate Change and Natural Hazards, grades 10-12
- Farm to Table: the Economics and Government of Food, grade 12
- Financial Literacy, grade 12
- Introduction to Business Law, grades 10-12
- PLTW (Project Lead The Way) Environmental Sustainability – in the PLTW Pathways to Engineering strand
- Physical Education: various, all grades

The budget also includes funding for:

- **Athletics:** Efforts to increase student participation in interscholastic sports and the Summer Sports Academy, grow the number of Scholar Athletes, improve summer retention and recruitment of coaches, and continued improvement of athletic facilities
- **Security & Safety:** Installation of Diamond Defense Ballistic Film at all school vestibules, and continuation of annual drilling, testing and training with students, staff, SROs, and local emergency management teams
- **Transportation:** Transition to Durham Bus Services, 70 new buses, implementation of 2023-24 Efficiency Study recommendations, assisting parents/guardians and students in transition of Church Street bell times, and continued efforts to implement NYS Zero Emissions mandates
- **Food Service (self-funding):** Continuing the culinary focus, expanding vegetarian protein offerings and access to meals and after school snack/meal programs, and engaging students in menu planning and recipe selection

- **Facilities & Operations:** Continued work on capital and various maintenance projects, and working with NYSEDA and their On-Site Energy Manager, and completing energy audits at several schools
- **Information Technology:** Enhanced cybersecurity, implementation of Parent Square communication platform, upgrades to network, phone system, and security cameras

## Proposed Budget FAQ's

**Does the White Plains City School District comply with the New York Property Tax Law?**

**YES.** The proposed tax levy increase of 1.67% is below the maximum allowable tax levy limit of 3.31% that is calculated for 2025-26 through a prescribed State formula.

**Does the tax levy indicate whether my taxes will rise?**

**NO.** The tax levy only represents the amount of school district funding provided by local property taxes after taking into account other sources of revenue. Residents' tax bills are determined by several factors that are out of the District's control, including assessment levels, which vary by municipality, and equalization rates, which are set by the New York State Office of Real Property Services.

**How would the proposed budget affect taxes?**

While the final tax rate for 2025-26 cannot be determined until June when final assessments and equalization rates are available, the City of White Plains estimates a tax increase of 1.94% or \$17.69 monthly for a home in the District, with an average property tax assessed value of \$15,000 due to a loss in taxable property assessments.

**Did the District reduce any programs or services to students?**

**NO.** Through the District's commitment to long-range planning and pursuit of greater efficiency, we have not only been able to sustain our instructional programs, but also further enhance the educational opportunities for all students through the reallocation of resources, **no new monies.**

**Why did the District change Church Street arrival and dismissal times?**

The District commissioned an Efficiency Study in 2023-24 to evaluate the existing transportation program and to determine next steps to find a new provider. As part of that analysis, it was identified that Church Street arrival and dismissal times should be aligned with the District's other elementary schools in order to comply with NYS Pupil Transportation Department recommendations that routes should be designed and buses scheduled so each bus can make two or more morning and afternoon trips. If the District were to continue stand-alone buses, expenses would increase by \$2.1m.

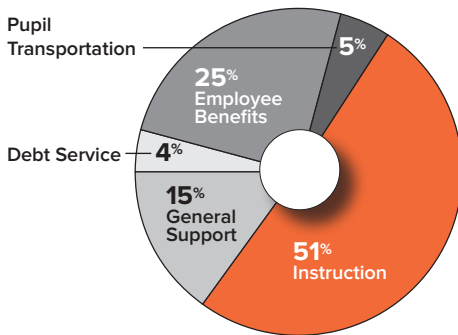

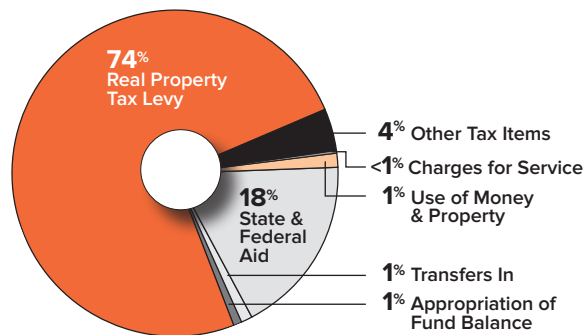

## Voter Information

**School Budget Vote** In-person voting will take place Tuesday, May 20, Noon to 9pm. To determine your voting location, go to <https://lh.findmypollplace.com/whiteplainscsd/>. Note: Voters who previously voted at the Battle Hill Community Room will now vote at El Centro Hispano, 245 Central Ave.

**Voting Qualifications** To vote in this election, an individual must be a registered voter, a resident of White Plains for 30 days prior to May 20, and at least 18 years of age.

**Absentee & Early Mail Ballots** Registered voters who choose to vote by absentee or early mail ballot need to submit an application, which may be requested from the District Clerk. For more information, call 914-422-2071.

**Board of Education Election** Voters will elect two members to serve a three-year term on the Board, beginning July 1, 2025. Candidates, in the order they appear on the ballot, are: xxxxxxxx
