Blackstone Elementary will expand opportunities for movement and wellness through structured physical education, recess enhancements, after-school sports, and school-wide fitness challenges. These will instill lifelong healthy habits, improve physical and mental health, and create a culture of energy and engagement across our school community. The program will:</p> <ul style="list-style-type: none"> • Enhance learning environments through access to critical tools and resources. • Promote equity by addressing barriers to academic and physical success. • Foster student well-being through physical activity and digital inclusion. • Strengthen the bond between Blackstone Elementary and community partners like the NFL Foundation. <p>This grant will pay for digital learning tools and indoor equipment for recess.</p>

Activity levels will increase through inclusive, engaging programming.</p>

Through school-wide campaigns and classroom integration of healthy habits education, awareness of the importance of exercise, nutrition, and overall wellness will grow.</p>
