ROBOTICS AND AUTOMATION INSTRUCTOR (CIP 15.0403)

POSITION DESCRIPTION:

The Robotics and Automation Instructor will be responsible for providing comprehensive instruction that prepares high school students for careers in automated manufacturing and related fields. This includes the operation, maintenance, and troubleshooting of electromechanical systems, robotic components, control systems, and industrial automation technology.

Instructional responsibilities include:

- Safety protocols and industry standards
- Industrial robotics and automated systems
- Basic and advanced electronics
- Hydraulics and pneumatics
- PLC programming and troubleshooting
- Mechanical systems and precision measurement
- Engineering graphics and CAD software
- Industrial networking and smart technologies
- Problem-solving and critical thinking skills
- Soft skills including ethics and teamwork
- Integration of sustainable energy concepts where applicable

The instructor will also be expected to integrate hands-on, project-based learning strategies and remain current with evolving industry standards. The role includes participation in advisory committee meetings, curriculum development, student assessment, and professional development.

QUALIFICATIONS & REQUIREMENTS:

- High school diploma or GED required and have a minimum of 4 years (8,000 hours) of documented, paid work experience in automated manufacturing, robotics, or electromechanical technology

- Willingness to enroll in and maintain enrollment in a PA Department of Education approved career and technical teacher certification program

- Must pass the Occupational Competency Assessment (OCA) in Automated Manufacturing (2109 CIP 15.0403)
- Strong communication, organizational, and classroom management skills
- Experience with or willingness to learn instructional strategies for secondary education
- Current clearances: Act 24, Act 34 (PA Criminal History), Act 114 (FBI), and Act 151 (Child Abuse), all dated within the past year and Act 168 Disclosure Releases

- Must pass a pre-employment drug screening
