- Improve skin health by performing personalized consultations, facials, and exfoliation treatments.
- Conduct advanced skincare analysis and treatments such as chemical peels and microdermabrasion.

### PROGRAM REQUIREMENTS\*

- Current Juniors may apply. No early grads may apply for GateWay.
- Per State Board of Barbering & Cosmetology, the following requirements are mandatory for acceptance:
  - Earned ten total high school credits
  - Must be 16 years of age by the first day of class: **July 28, 2025**
- West-MEC requirements are:
  - Two credits of English with a C or better
  - One credit of Math with a C or better
- Copy of unofficial transcript
- Proof of residency in West-MEC district boundaries
- Copy of birth certificate and immunizations/State Exemption Form due at the time of enrollment
- Student State issued ID, driver's license, or driver's permit due at the time of college enrollment
- Parent Proof of Citizenship & 1-year Arizona residency due at time of college enrollment (non-resident is responsible for the difference between in-state and out-of-state tuition)
- All required course hours must be completed within each quarter. Limited makeup hours available.
- Transportation is not provided by West-MEC. Families are responsible for providing transportation to and from the community college.
- Students will practice on both fellow students and adult clients, male and female, who schedule appointments at the salon.

\*Program requirements are subject to change per industry age restrictions, certification requirements, and administrative discretion.

**Meeting program requirements does not guarantee enrollment.**

### COST REQUIREMENTS

Upon enrollment into the program:

- \$1,250.00 registration fee (\$150 is non-refundable) which includes enrollment processing, supplies, uniform shirts, student kit, & textbooks.
  - \$1,250 is non-refundable after day 1 of class.
  - A payment schedule will be provided at registration.
- It is recommended that students have access to a personal computer and reliable internet outside of class to complete assignments and projects.
- Dress code is reviewed to meet professional industry standards. Dress code requirements are addressed before the start of classes.
- Success in the program depends upon the student having access to a personal computer (no iPad or tablet) and reliable internet outside of class to complete assignments and tests.

Tuition

- If a student graduates or obtains a GED prior to program completion the student will be responsible for tuition.
- Empowerment Scholarship Account (ESA) recipients are responsible for tuition. West-MEC is an approved vendor.
- Student Tax Credit (STO)/Private School Scholarship recipients are responsible for tuition.
- Students who reside outside of West-MEC boundaries are responsible for tuition.

### INDUSTRY CREDENTIALS

*If eligible, students will have the opportunity to test for the following credentials.*

FEES REIMBURSED BY WEST-MEC; It is the responsibility of the student to maintain copies of all earned credentials.

  - Arizona Board of Barbering and Cosmetology License in Aesthetics
- This industry credential is often preferred for employment in the field. Candidates with this industry credential are likely to be given priority in hiring.

## ENROLLMENT INFORMATION

- Acceptance into West-MEC programs may be competitive.
- Students may only be enrolled in **one** West-MEC Central Program at a time.
- The order for filling seats by grade level is as follows:
  - Current Juniors
- Applications are ranked in part by attendance, GPA, discipline, and career choice (ECAP).
- Copy of birth certificate, proof of residency, and immunizations/State Exemption Form due at the time of enrollment.
- Program hours are not excused for participation in extracurricular activities, athletics, vacation, or employment.
- West-MEC priority application submission date is in February. Contact your school counselor for your school's application deadline.
- West-MEC students served under an IEP/504 must self-advocate for reasonable accommodations through the College Disability Resource Office. Approved accommodations may differ from those provided in the high school. The Americans with Disabilities Act requires institutions of higher education to provide reasonable accommodations to those with documented disabilities, provided an undue hardship is not created. It is the student's responsibility to inform the Disability Resource Services (DRS) Office directly of his or her need for accommodation(s), each time he or she registers for a new course. All accommodations and academic adjustments are course and semester specific and do not carry over from semester to semester or course to course.

## STUDENT SUCCESS INDICATORS

- History of good attendance and discipline (Students who do not complete 100% of the required hours and/or do not earn a grade of 80% or higher each semester may be withdrawn from the program.), and on track for graduation
- Strong interest in a chosen career pathway
- Strong hand-eye coordination with fine motor skills and stamina
- Manual dexterity and physical ability to use instruments & equipment. Ability to focus and pay attention to detail on small specific areas.
- Able to communicate with clients to create a beauty regimen/treatment plan
- Ability to get along with other students and cooperate with the instructor
- Ability to work accurately/follow procedures to an industry-standard
- Ability to practice all procedures on each other (Certain medications may be contraindicated for services and may negatively impact student ability to participate fully)
- Strong technical reading and study skills; the textbook for this course is written at the college reading level
