## **VIM LI CAS PEB HO XEEB COV MENYUAM KAWM NTAWV?**

Peb xeem (tseem hu ua ntsuam xyuas) cov menyuam kawm ntawv kom teb tau cov lus nug tseem ceeb xws li:

- *Cov menyuam puas kawm tau yam peb xav kom lawv kawm tau?*
- *Puas yog tag nrho cov menyuam tab tom txhim kho thiab raug teeb meem raws cai?*

Peb yuav tsis txhim kho kev kawm ntawm cov menyuam tsuas yog los ntawm kev xeem cov menyuam xwb. Cov kev xeem ntawm cov menyuam kawm ntawv muaj feem xyuam rau qhov peb cov xibfwb siv cov txiaj ntsig kev xeem (hu ua cov ntaub ntawv) li cas. Cov ntaub ntawv xeem yog siv raws li ib feem ntawm kev xav txog peb cov kev kawm thiab kev ua hauv qib kawm ntawv, qib tsev kawm ntawv, thiab qib cheeb tsam.

## COV HOM XEEB UA NTEJ TSEV KAWM NTAWV HAUV MINNEAPOLIS LUB TSEV KAWM NTAWV PEJ XEEM YOG DAB TSI?

1. **Kev Xeem rau Xeev Kev Ua Raws Cai:** Siv nrog tag nrho cov menyuam kawm ntawv los txiav txim seb cov menyuam puas tau raws li cov qauv qib kawm thiab saib xyuas cov kev kawm nyob rau hauv tsev kawm ntawv, cheeb tsam, xeev, thiab qib ntawm tsoomfwv.
2. **Kev Ntsuam Xyuas Tsev Kawm Ntawv:** Siv nrog tag nrho cov menyuam kawm ntawv los txiav txim seb cov menyuam puas ua raws cai rau lawv cov qib kawm thiab ua kom loj hlob. Nws kuj tseem siv tau los saib xyuas cov tswv yim nyob hauv tsev kawm ntawv thiab qib cheeb tsam.
3. **Kev Xeem hauv Chav Kawm Siab Tshaj:** Siv nrog tag nrho cov menyuam kawm ntawv los txiav txim seb cov menyuam puas kawm tau txuj ci, lub hom phiaj kawm ntawv, thiab/los yog cov qauv uas tus xibfwb tau taw rau. (Piv txwv li, kev xeem hauv chav kawm, kev xeem kawg ntawm tshooj, thiab lwm yam.)
4. **Kev Ntsuam Xyuas Ntaub Ntawv:** Siv nrog qee cov menyuam kawm ntawv uas kawm tsis zoo thiab cov menyuam kawm ntawv uas tsis qhia kev loj hlob kom txiav txim seb cov txuj ci tshwj xeeb twg cov menyuam kawm ntawv ntawd xav tau kev pabcuam nrog.
5. **Kev Ntsuam Xyuas Kev Nkag Siab:** Siv nrog qee cov menyuam kawm ntawv uas tau txais kev pabcuam tshwj xeeb tsis tu ncuu (nrog rau ib lub lim tiam, ob lub lim tiam, lossis txhua lub hli) los txiav txim seb cov menyuam kawm ntawv puas tau nce qib txaus raws li qhov kev pabcuam tsom mus rau txuj ci. (Piv txwv li, kev pabcuam nyeem ntawv.)
6. **Kev Xeem hauv Chav Kawm:** Siv nrog tag nrho cov menyuam kawm ntawv txhua hnuv los xav txog kev ua tau tam sim ntawd ntawm kev qhia tam sim no thiab txiav txim seb cov menyuam puas tau raws cov hom phiaj kawm ntawv txhua hnuv.

Cov tsev neeg yuav tsum tau thov ib daim foos Opt Out los ntawm lawv lub tsev kawm ntawv, ua kom tiav qhia tias xeeb lossis cheeb tsam kev xeeb twg lawv tsis xav kom lawv tus menyuam koom, thiab xa rov qab mus rau tsev kawm ntawv.
