#### HIGH SCHOOL CREDIT RECOVERY

Ms. Melissa Espana presented the Credit Recovery restructuring.

- Credit Recovery is an opportunity for students to regain lost credits from courses they do not pass so they graduate with their high school cohort.
- Edgenuity program will be used. It's an evidence-based program.
- Online course specifically modified to match the Paterson Public Schools curriculum.
- Program for sophomores, juniors, and seniors.
- The program will run from Monday through Friday, and on Saturdays if needed.
- Students must attend in-person four hours per week per course. Students may take two courses during any given Credit Recovery session.
- There will be no free movement throughout the course. Students must sit through every piece of the entire program. Students must complete 100% of the course in order to receiving a passing grade.
- Each course runs 60 hours.
- The program will monitor a student's idle time and active time.

Student graduation rates will reflect a decline as a result of this program.

Principals have sent out letters to parents in multiple languages announcing the program. There is also website notification and robocalls.

It's important that teachers be able to communicate to the students the changes in the Credit Recovery program. They should be the first to detect that the student needs the program, not the parents.

There is a website page available with all the information on the High School Credit Recovery Program for parents. It contains breakdown of grades, requirements for the students, and schedules for each of the buildings the program is housed in.

The courses not found in Ingenuity are:

- Health 1-4
- ESL 1-4
- Spanish 4

Why do students find themselves in need of Credit Recovery in the first place?

- Student attendance is an issue.
- Perception that Credit Recovery is a viable substitute for passing the courses during the school year.
- There is a mentality on the part of some teachers that students can fall back on Credit Recovery.

It's important that teachers are supported by the administration, and that students are held accountable for their efforts to attend Credit Recovery.

Recommendations proposed are a potential daytime adult school for select students who show promise of attendance to earn their diploma. Students would graduate in two different cohorts.

Another recommendation would be for failing freshmen to attend Saturday marking period makeup sessions. If they pass these Saturday courses, that score would be averaged into their marking period failing grade.
