2. Discussion Items

2.a. Tax Collector Software Update... Mrs. Luckock

Minutes

Mrs. Luckock has been in contact from the county treasurers office regarding the Borough of Conneautville and a software update. In order to accurately share the information sent to her by their attorney. The Borough Conneautville tax collector passed away and the deputy tax collector finished the year. The borough has assigned their borough secretary for the 20225 to do be the tax collector and Patty Franz to be the deputy tax collector. The county has approved the 2025 taxes and understood the district sill needed to know wo was approved as the collector for the school taxes.

Mrs. Luckock then shared that the county has purchased new software to make a seamless transition of parcels saving time for all involved, it removes human error and allows all changes done in the Assessment office. They can send new bills to the new address/owners and eliminates duplication. The online feature provides the tax collectors balance with the treasurers office as soon as the last payment is made to the taxing bodies. Deena Sites for the Conneautville Borough is all setup on the new system and it can process the school tax payments the same as all the collectors in the district. Tax payers can pay to the same collector which will ease some confusion. The County has made us aware of the situation and asks the board to consider approving the same individuals to avoid future confusion. The board was in consensus of approving this next week.

Mrs. Luckock invited Mr. Jim Shones the Realtor representing the district with the Conneaut Valley Middle School property and asked him to update the board on the status of the property.
