# FROM THE SUPERINTENDENT



Dear Dansville Central Schools Families and Community Members,

Dansville Central School District takes a collaborative approach to preparing every student for their successful future. We accomplish this by creating an inclusive and engaging environment that provides students with the skills and experiences they need to thrive as confident, successful, and contributing members of society. **This is our mission and vision.**

We are proud to advance a school budget that aligns with our district’s mission and vision. Our Board of Education has worked hard to develop a budget that prioritizes high quality academic and extra-curricular programming for our students while meeting the changing fiscal realities faced by our district and taxpayers.

Together, we have much to celebrate this year. Dansville Central Schools took significant steps toward establishing ourselves as a model district in our region. We collaborated with our entire community to establish a Blueprint for Excellence Strategic Plan that will guide us on a path of continuous improvement over the next three years. Our students experienced academic growth and many have been awarded for their academic achievements. We have enjoyed regional recognition for our extracurricular programs and accomplishments. Our athletic teams have had many scholar-athletes and have captured regional titles and recognition. We have also focused on activities that support career pathways and the mental health of both students and staff.

Together, we have also faced our share of challenges. This year brought significant increases to health and liability insurance premiums and increased costs associated with fuel, utilities, and materials. We also had two local companies come on to our tax rolls which inflated the tax levy. Both state and federal funding uncertainties have added to the challenge of developing a stable local budget, leaving many unanswered questions.

To successfully navigate the future, we need your support and partnership. The proposed 2025-2026 budget of \$42,344,525 supports the preservation of high-quality programs, staff, and services, while respecting the position of our taxpayers. The increase in the proposed budget, responsibly remains below the rate of inflation with the greatest increases being put toward the programs that impact our students the most. It also results in no cuts to teachers and staff.

In spite of these challenges, we have achieved a balanced budget resulting in a modest increase in school tax to the average homeowner based on the assessment of your home. The impact is illustrated in this chart:

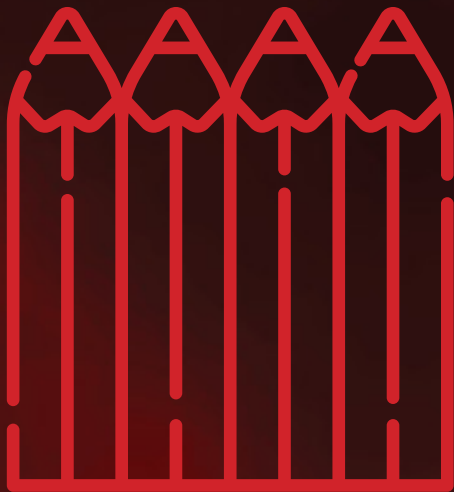

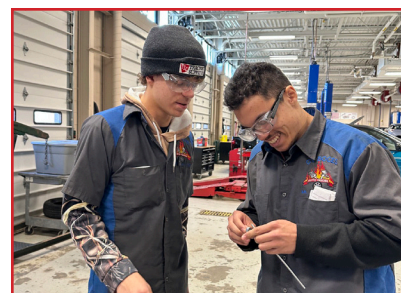

## BUDGET BASICS

### BALANCED BUDGET

**Expenses = Revenues**  
(budget needs) (income sources)

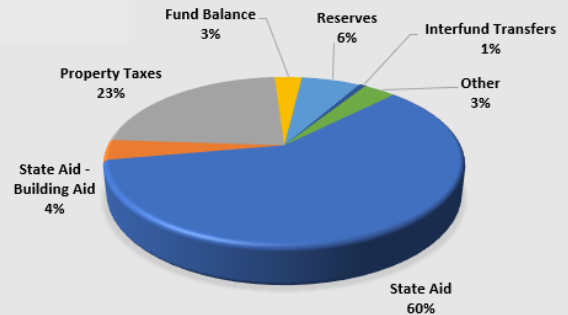
**Expenses:** Salaries, Benefits, Supplies, Equipment, Contractual Costs, BOCES Costs

**Revenues:** Taxes, State Aid, PILOT Payments, Fund Balance, Reserves

### Tax Levy Explained:

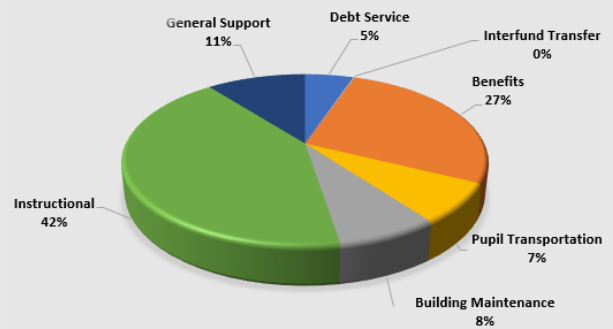
The NYS "tax cap" is an 8-step formula that limits how much the school tax levy can grow each year. It uses 2% one part of this formula to limit the impact of inflation. However, other parts of the formula can impact the final allowable tax levy. One of these factors is the way large companies are taxed. This year, two companies are changing the way they pay taxes and must now be included on the general tax rolls. Because of the size of the companies compared to a typical home, this drove up the tax levy. Only a portion of the allowable increase will be reflected in school taxes for the average homeowner. This is further reduced by your STAR exemption status. The impact to you is shown by the figures in the chart.

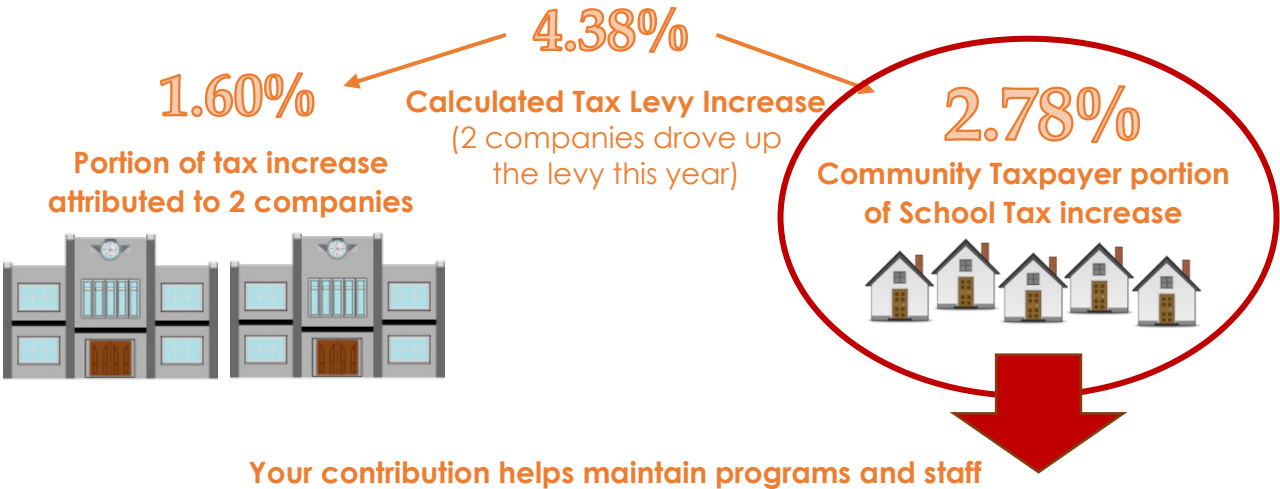

The **Administrative** component of the budget includes expenses for central administrative and support salaries and related costs, Board of Education expenses, business office expenses, and insurance.

The **Program** component of the budget includes expenses relating to instruction, including salaries, benefits, textbooks, supplies, transportation, and athletics.

The **Capital** component of the budget includes costs associated with custodial salaries and benefits, building maintenance costs, debt services costs, and capital outlay expenses, not to exceed \$100,000, for minor building renovations and site work.

### PROPOSITION #1: 2025-26 School Budget

RESOLVED, that the Board of Education of the Dansville Central School District is hereby authorized to expend the sum of \$42,344,525 for the school budget for the 2025-26 school year and to levy the necessary tax on the taxable property of the school district.

### PROPOSITION #2: Purchase School Buses and Vehicles

Shall the following resolution be adopted to wit:

RESOLVED, that the Board of Education of the Dansville Central School District is hereby authorized to undertake the acquisition of three (3) large school buses, one (1) small wheelchair accessible school bus and one (1) SUV/Van, all at an estimated maximum aggregate cost of \$795,000, less trade-in value, if any, and to appropriate and expend from the existing school bus and equipment purchase reserve fund \$145,000 for such cost, and that the balance of such cost, or so much thereof as may be necessary, shall be raised by the levy of a tax to be collected in annual installments; and, in anticipation of such tax, debt obligations of the school district as may be necessary not to exceed \$650,000 shall be issued, or the School District may enter into an installment purchase contract if the Board of Education determines that it is in the best interest of the School District to finance the purchase in that method.

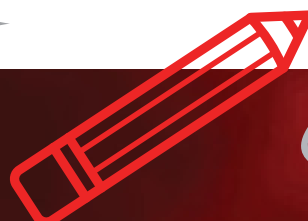
### PROPOSITION #3: Reserve Fund Expenditure

Shall the following resolution be adopted to wit:

RESOLVED, that the Board of Education of the Dansville Central School District is hereby authorized to expend \$140,000 from the existing school bus and equipment purchase reserve fund for the acquisition of one (1) wide-area lawnmower, at an estimated maximum cost of \$140,000.
