 - Approve submission of an application for the 2022 Full Service Community Schools Program Grant, pending grant application release from the US Department of Education, to encourage coordination of academic, social, and health services through a consortium of public elementary and secondary schools and community-based organizations, non-profit organizations, and other public or private entities, and authorize a contribution of matching and inkind services. APPROVED
 - 2. Approve submission of the American Rescue Plan (ARP) Homeless II application and accept the funds to support efforts to identify homeless children and youths, provide them with comprehensive, wrap-around services that address needs arising from the COVID-19 pandemic, and allow them to attend school and participate fully in all school activities, to be utilized through September 30, 2023, in the amount of \$420,130.00. **APPROVED**
 - 3.
