Comm. Simmons read the Open Public Meetings Act:

## RESOLUTIONS FOR A VOTE AT THE WORKSHOP MEETING

## Resolution No. 1

Whereas, the Paterson Public School District approves the payment of bills and claims dated through December 6, 2022, beginning with check number 234217 and ending with check number 234289, in the amount of \$10,708,291.83, and direct deposit number beginning with 1527 and ending with 1549;

Be It Resolved, that each claim or demand has been fully itemized, verified and has been duly audited as required by law in accordance with N.J.S.A. 18A:19-2.

#### Resolution No. 2

WHEREAS, in accordance with the American Rescue Plan Elementary and Secondary School Emergency Relief Fund (ARPESSER III), districts accepting ARP-ESSER funding are required to update the Safe Return Plan for the continued safe return to inperson instruction and continuity of services for all schools, as well as post the updated plans on their websites as required by ARP Act section 2001(i)(1) by December 23, 2022; and

WHEREAS, this plan serves as local guidelines for all instructional and non-instructional school activities throughout the entire ARP-ESSER project period and must be updated every six (6) months through September 20, 2023 or whenever there are significant changes to CDC recommendations for K-12 schools.

WHEREAS, in response to this order the Paterson School District is submitting the updated American Rescue Plan; and

NOW THEREFORE, BE IT RESOLVED, that the Board hereby approves the district's submission of the American Rescue Plan (ARP) Safe Return Plan.

## Resolution No. 3

WHEREAS, the districts' 5 Year Strategic Plan: Paterson- A Promising Tomorrow's Goal 1 is to create a student- centered learning environment to prepare students for career, college readiness and lifelong learning, and;

WHEREAS, field trips afford students a firsthand educational experience that is not available in the classroom, and;

WHEREAS, the Assistant Superintendents have approved/recommended the addition of the attached field trip locations;

THEREFORE BE IT RESOLVED, the Paterson Board of Education accepts the addition of the attached list of approved destinations as appropriate field trip sites for the students of the Paterson Public Schools for the 2022-2023 school year.

#### Resolution No. 4

WHEREAS, Policy and Regulation 7510 authorize the Superintendent, upon consultation with the Board of Education (the "Board"), to permit the use of school facilities for any purpose not prohibited by law, provided that such use does not interfere

with the educational and co- curricular programs of Paterson Public Schools (the "District");

WHEREAS, the District received a request from a film production company (Day of the Fight, Inc.) which is currently making a film called "Day of the Fight," which is written and directed by Film and TV star Jack Huston (American Hustle, Ben-Hur) and stars actor Michael Pitt (Boardwalk Empires, Seven Psychopaths) in the leading role.

WHEREAS, the film is a redemption story about a former champion boxer whose life has fallen apart. The film takes place over the course of one single day, the day of his first major prize fight in years. Interweaving between the day of his fight and memories of his past, the film tells the tale of a man who is trying to put the pieces of his broken world back together.

WHEREAS, the filmmakers are requesting to film at Public School No. 2, 22 Passaic St., in the back playground area that lets out on Market Street.

WHEREAS, the action in the scene is as follows: A father is standing on the sidewalk on Market Street opposite the schoolyard. He watches as his daughter enters the schoolyard on Market Street and walks into the school. She looks back before entering the school and waves at him before walking in.

WHEREAS, the filmmakers are requesting access to the schoolyard, as well as the use of one of the abutting doors that lead out to the schoolyard. The actor playing the daughter will basically enter the building through said door and close the door behind her until we cut. No actors or crew members will enter the school beyond the vestibule on the other side of the door.

WHEREAS, the filmmakers are also requesting the ability to place extras in the schoolyard to give the scene the feel of an active school in the morning.

WHEREAS, the filmmakers need one day of filming, Friday, December 16, 2022, and an additional day to set up beforehand and another day after for restoration.

WHEREAS, the filmmakers have provided the scripted dialogue of the scenes to be filmed (attached).

WHEREAS, the District owns and controls a school facility known as Public School No. 2 and located at 22 Passaic St., Paterson, NJ 07501;

WHEREAS, Public School No. 2 Principal Vanessa Serrano has verbally affirmed that the filming will not interfere with the school's instruction and function on the requested date.

WHEREAS, use of this facility will be subject to the provisions of Policy and Regulation 7510, and governed by a written Facility Use Agreement that sets forth standard use/service fees and insurance and liability requirements;

WHEREAS, the Superintendent and Board have reviewed details of the proposed filming activities and believe they will not interfere with the District's educational and co-curricular programs;

Comm. Redmon: Following along with what the President said at the beginning of the meeting, we're shortening the public portion to the first 100 speakers with a minute to speak.

Comm. Simmons: The total time for public potion is two hours.

Ms. Rosie Grant: Good evening, Commissioners, Madam Superintendent, staff, and community members. I thank you for this opportunity to speak. I speak on behalf of Paterson Education Fund. First, our condolences go to the grieving family. Losing a child is devastating and I'm so very sorry for your loss. We extend congratulations to the young man who won the scholarship and to all the students and staff who participated in this evening's production. I wanted to alert you that PEF participated in the Race Forward Conference. Linda Reid went to Phoenix to be part of a panel. They talked about Restorative Practices in Paterson as a co-governance model of schools and communities working together to move a school improvement agenda. We will share the national report with you when it is available, but Paterson was featured in front of an audience of 3,500 people across the United States. We're staffing up for our local implementation, so anyone who is interested in learning to facilitate Restorative Practices and do trainings, please be in touch through our Paterson Education Fund Facebook page.

Mr. Charles Ferrer: Good evening, everyone. As First Vice President of the Paterson Education Association, but also as an employee of the Paterson School District, our members feel like they're currently in an abusive relationship with almost no way out. One of the most important things is that enough money has been given, according to the Commissioner Secretary of Education, so that every employee in education should be paid a livable and competitive wage. I don't understand what the problem is here when you have the American Rescue Plan money plus the local and state money to the tune of \$350 billion that goes throughout the United States. There's more than enough money to come to the table and pay your employees what they're entitled to. Stop disrespecting some of your people. There is not supposed to be a have and a have-not situation and that's what we've created here. Some people get everything and when we ask...

Mr. Gennaro Tortoriello: Good evening. Why are you denying the community and our members an opportunity to speak here tonight? It's the job of the Board and the district to ensure that our students receive quality services. Part of that involves staffing schools appropriately. There are nine math vacancies in your largest high school. There are multiple special education teachers in elementary schools covering classes because you don't have enough teachers. Here's a solution – settle the damn contract. Stop playing games, settle the contract, and show our members the respect that they deserve. What's going on now is unacceptable. It's criminal for the children who are not receiving the services and it's disrespectful to the staff. None of you would allow this if this was happening for your children. Unacceptable!

Mr. Jeffrey Gutt: This is Jeffrey Gutt and I want to share with my community my respect for my district and the children in my care. I've been serving in the Paterson community for over 20 years in Paterson Public Schools in any capacity that Paterson asked me to serve. I demand a fair and equitable contract, respect for me, my family, and my children that I teach in that classroom. My respect begins with a contract. Settle the contract now. My family can't survive. I can't be the best teacher that I can afford to be because we're drowning. Settle our contract. Thank you.

Ms. Camille Lewis-Francis: Good evening. I'm here to let you know directly that as a Paterson Public Schools employee I feel devalued. I'm a veteran teacher with veteran expertise. I'm also a specialist. This came by working hard at my craft. I enjoy perfecting my craft. This is because any knowledge I gain directly affects the students. Perfecting my craft didn't happen in one school year. It happened over 15 years. When someone with one or two years of experience is being compensated as if they had eight or nine years of experience, it devalues my hard work. It says to me that my hard work doesn't mean as much as that person. That's how I feel.

Ms. Tawnya Stojakovic: Good evening. What wonderful performances by the talented students of Paterson Public Schools. They must have great teachers. That's why teachers demand a fair and equitable contract. Respect begins with our contract. Settle now. Thank you.

Ms. Helen Dennis: My name is Helen Dennis and I'm a 20-year veteran teacher of the Paterson Public Schools. I love the kids I work with. I love the school I work in. I hate our contract or lack of it. Please, you cannot put students first if you constantly put teachers last. Settle our contract now. Thank you.

Ms. Debra DiPrima: Good evening Commissioners. I was very disappointed to hear that you would only allow the first 100 speakers tonight. I know that there were many more people who would like their opportunity and right to voice their opinion and speak to the Board. I'm here to urge you to settle the PEA contract. All our teachers who are showing up for our Paterson students every day deserve a fair and equitable contract. That goes for all staff, not just teachers. Settle the contract now.

Ms. Deirdre Karcher: I wish for you to settle our contract please. So many of our teachers are young and their pay has been frozen, and they have debts to pay and other things. If you remember in the past, it was absolutely devastating to our staff what happened a few years back. Please don't let that happen again. Settle our contract now. Thank you.

Ms. Christina Somma: We have great teachers and they're leaving to be valued in other districts. I'm guilty. I can no longer afford to stay in Paterson. My own family is suffering. I'm a 17-year highly effective teacher certified to teach k-8 and highly qualified in English. My husband is left to have three jobs to make up for what I can't contribute to our family of four. I have a five-year-old and a ten-year-old and I have put Paterson before my family for many years. Because I'm underpaid, my husband spends many hours away from us. For 16 years, my husband has asked me to leave Paterson. I started here and said I'd retire here. Since we're not right sized like others in our district, I'm seeking to be employed by other districts. Please do the right thing. Would you work under the contract you have proposed? The students suffer when dedicated teachers have to leave. What is the number of vacancies now? Don't you want loving, caring, educated, experienced, and dedicated teachers working in this district? You don't know what you have until it's gone.

Ms. Karyn Stephenson: Good evening. I'm a 34-year employee of the Paterson Public Schools. I have never felt so disrespected by this district. Please settle our contract now. Enough is enough. Thank you.

Ms. Danielle Bespalko: I'm just another fed up teacher asking you to please settle this contract as soon as possible. More and more teachers are resigning by the day. Despite filling some vacancies, more are still happening because we just can't take it anymore. Any Paterson teacher can get hired on the spot somewhere else right now.

You're forcing us out the door. The longer this battle goes on, we suffer, but the kids suffer the most. They can see that burned out teachers are affecting them beyond repair. If you care at all about the future of these kids, you'd settle this already. Please think if your child was in a class with no teacher, aide, or not getting the special services they need due to vacancies that stem from having no contract. How would you feel if it was your child not properly supervised or educated? Don't deny that this is wrong. Please do what's right for the students and the teachers of Paterson. Thank you.

Ms. Dayna-Marie Zisa: How many vacancies do we have right now? We're still dealing with not having a contract. Yet, people are getting right-size raises. I believe the Board of Education is spending \$16,000 to go to Miami Wednesday or Thursday this week. We deserve a contract. We deserve a livable raise. Our students deserve for us to be able to come to work every day not worrying about our bills and what's going on in our personal lives because we don't make enough money because we didn't get raises. Stop disrespecting us and give us a raise now. Thank you.

Ms. Gayle DeNicola: Good evening. Congratulations to the young man who got accepted into Brown University. Thank you so much to the choir members for that beautiful presentation. I've been a proud Paterson Public School teacher for 38 years. Right now, we all deserve a fair and equitable contract. Respect begins with our contract. Please settle now. We are losing very good teachers who don't want to leave. They love the students. It's just not economically feasible for them to stay. Thank you.

Ms. Lisa Reiner: I'm a 16-year veteran teacher. I dedicated my entire career to the City of Paterson. I love to serve my students. Yet, I make less than a first-year teacher in Newark. Does that seem fair? I'm asked every day by my family members why on earth I stay here. Lately, I've been wondering the same. I'm speaking tonight because teachers and staff deserve a fair and equitable contract now. It's time to stop playing the blame game and start taking serious consideration to our wellbeing. Otherwise, the mass exodus will continue. Mr. McEntee is not the PEA. I am. We all are. When you throw blame and shade at him, you're in turn doing the same to us. The back-and-forth between salary guides and who is responsible is petty and does nothing to solve the problem. Meanwhile, you neglect to tell the public that you want to give us zero. Your Board is dangling \$7,500 carrots in the faces of new hires using COVID relief funds while we line the streets begging for crumbs. You should be using COVID relief funds to retain us. We elected you, Ms. Shafer, at the time you gave such a great contract. I don't understand why you can't end the time with us the same way. Stop trying to defend your inactions and start acting. Settle our contract. Thank you.

Ms. Michele Nardino: Please settle the contract now. We are losing way too many teachers to other districts. Paterson teachers need a competitive wage or, as you call it, need to be right-sized the same way that the assistant superintendents had their salaries right-sized. What's good for the goose is good for the gander. Thank you and have a good night.

Mr. Steve Dinnerman: I've been a teacher here in Paterson for 15 years. My salary today is not much more than what I made when I first walked in the door. It's embarrassing. It's pathetic. Luckily, I'm off tonight so I can speak to you all. Normally, I'm working one of my three extra jobs – one after school, one at night, and one on the weekends. I have two young children that I don't get to spend as much time with because I need to work extra jobs just to keep the lights on and put food on the table. The district has invested a lot of money on SEL and mental health. You're creating a mental health crisis amongst your staff. You have no idea how stressed and beaten

down we are. We cannot survive. We're not just complaining. Do the right thing. Give us a fair and equitable contract. Thank you.

Ms. Greta Mills: Hello everyone. Please settle the contract. When I say settle, I mean we deserve a raise. You have teachers out here putting plays and shows together and this has been going on for years. At this point, we need to be making sure that we get paid for our services. Time out for free things, constantly doing things, and trying to help the students because we care, but then the Board is not there trying to make sure that we get paid. We want to do what we need to do for our house, pay our bills, survive, not struggle and work so many jobs. I know about working massive amounts of jobs just to pay the bills and put my son through college. We need a contract that shows that we are going to get paid a good amount of money. The same way everybody else is sitting there getting paid, we need to get paid for our services. We work hard every day...

Ms. Raquel Ford: There are 10 vacancies in my building. We have no bilingual homeroom teachers in kindergarten, first, second, and third grades. In January, we will be up to 12 vacancies. Settle the contract.

Ms. Noreen Veloz: Good evening. I'm speaking on behalf of not only myself, but all the people that cannot speak tonight. First, we had COVID. Then we had the nonsense with the health insurance. Now we have the nonsense with the contract. If you really cared, you would settle this contract. We are on our way back to state control if we cannot work together. Thank you.

Ms. Felicia Eason: My name is Felicia Eason. I'm a Paterson voter, resident, and longtime Paterson Public Schools employee. Settle our contract fairly. Settle it now. Thank you.

Ms. Responda Sims: Good evening to all. My name is Responda Sims. I've been an employee of Paterson Public Schools for 23 years. I'm really upset over the \$7,500 bonus. That truly was a slap in the face. That's over \$800,000 that could have been used towards the contract. Non-bargaining received a cost-of-living raise and other large substantial raises at central office. This \$7,500 could have been used as good faith to make teachers stay in Paterson. Instead, you used it for other means. Settle the contract now. Thank you.

Ms. Joy Spinelli: Good evening, Commissioners. My name is Joy Spinelli. I've been a teacher in the district since 2000. I've been lucky enough to work alongside some of the greatest teachers in the state. It is heartbreaking watching everyone leave. Every child deserves a teacher in their classroom. Please settle the contract.

Ms. Kathleen Renegar: Good evening, my sympathies to the family who lost a child. You need to settle the contract fairly and soon. I teach juniors and I've had several of them ask me if I was going to leave. You're causing anxiety amongst your students. They're losing teachers who have been here for over 10 years, not just new inexperienced teachers, but excellent teachers. You're causing them anxiety. We deserve a fair and reasonable contract. Thank you.

Ms. Julie Lorman: I'm asking you to simply settle the contract. Thank you.

Ms. Stephanie Warlick: Good evening, my name is Stephanie Warlick. I'm a teacher at School No. 9 in Paterson for over 15 years. I teach middle school math and I love my job. Unfortunately, I have to have two other jobs just to pay my bills because the take

home pay that I receive is less and less every year. Not only is my take home pay less, but my actual base salary has barely raised at all in 15 years. After sitting frozen for four years and losing two years of my experience in the past, if I lose any more time and pay I will have to leave Paterson with the many other people who have left this year. I'm not only asking you to settle our contract, but I'm also asking that you settle one with a fair increase for what has changed in our country and our world over the last few years. Inflation is insane. Groceries are out of control. We need to be able to pay our bills so that we can support your children. If we can't support your children, the school system will fail. The only way to put your children first is to put...

Ms. Megan Anderson: Good evening. Please settle our contract now. Thank you.

Ms. Roneea Bundick: Good evening. As an educator in Paterson for over 20 years, a resident, homeowner, taxpayer, and voter, I'm asking for a fair and equitable contract. Thank you so kindly.

Ms. Amy Reyes: Good evening. I'm asking you to please settle a fair and equitable contract.

Ms. Stacey Rzeszutek: I'm a 17-year Paterson veteran who should be at the top of the guide. Instead, I'm three years away making less than some first-year teachers because of lost steps from previous contracts. I still show up every day for my students despite the lack of respect from you. Right-size our salary! We demand a fair and equitable contract. Respect begins with our contract. Settle now. Thank you.

Mr. Vince Gurnari: I've been 21 years in Paterson. I teach economics and social studies. Please settle this contract. Our students are hurting. I cannot tell you the number of times a week I have to explain to a student why they're sitting in an empty classroom, why their teachers are leaving. I had a student this week break down because he's sitting in classes with no teacher all year. He's a senior sitting in classes with no teacher. What are we preparing these students for? Settle the contract now. Thank you.

Ms. Arlethia Kelley: Good evening. My name is Arlethia Kelley. I would like to say that the greatest contribution to our schools is our teachers. The ones who are suffering are the students. Teachers have left and will continue to leave if you don't offer competitive salaries. Stop the games. Settle the contract now. Put our students and students first. The children of Paterson will be left behind. Thank you.

Ms. Ivrielle Dworkis: Good evening to Commissioners and Superintendent Shafer. Thank you for allowing me to speak tonight. I have been here only eight years. Compared to the others who have been here 25 and 30 years, I've only been here a small amount of time. Four years ago, when we settled our last contract and Ms. Shafer seemingly expressed how much she cared about the students of Paterson, I find it difficult to believe now that she still cares as much when she's not showing any care at

You hire teachers at such a high rate of pay that it's forcing the people who have been here for years to leave because it's disrespecting them. It's very unsettling to be a teacher here for 10 or 15 years and have somebody come with one year's experience making more money than you. Instead of hiring a new teacher that's forcing more teachers to leave and increasing the exodus, how about settling our contract, giving us fair pay, and keeping the people who really want to be in Paterson and are really dedicated to the children? Settle our contract now. None of you would ever settle for the type of contract that you initially want us to sign. Please settle our contract and keep the wonderful staff that you currently have. Thank you.

Ms. Nicole Fuller: Good evening, everyone. My condolences to the family. Ms. Lina Barbir: Good evening. Paterson children deserve the best teachers and education. Keep teachers in the classroom. My colleagues have said it all. Please stop the suffering and the anxiety. In these hard conditions treat others as you like to be treated. Please settle now. Thank you so much.

Ms. Namaty Asfour: Good evening. I've been a school nurse in Paterson for over 20 years. I work alongside an amazing staff. If you wish to retain your highly effective staff, we need a fair and equitable contract for all. We deserve it and so do our students. Thank you.

Ms. Dana Ruddy: My name is Dana Ruddy. I have been a behavioral disabilities teacher for the last eight years at School No. 20. I love my job. I love my students even more. But I cannot stand the disrespect anymore. Please settle our contract now. I'm a young mother and wife struggling to provide for my family with a frozen contract. In today's world where inflation is at an all-time high, the stress that I feel on a daily basis as I fill my gas tank, buy my groceries, try to pay my bills, and pay for daycare is unhealthy. We need to stop playing games and settle this. The lack of respect is disgusting. Respect your staff and settle this contract now. Thank you.

Ms. Wendy Rosales: We need to settle the contract. I have been working so hard to have all these certifications to be suitable for the students and do the best for them, but

I'm sure I'm speaking for many of us who teach three 90-minute blocks a day plus intervention periods every day with 30 or more students in a class without any bilingual or special education support. I leave every day wondering how I'm going to get up the next day and do this all over again. Without support, the challenges and expectations faced every day are both physically and mentally exhausting. Also, without a contract, most of us are faced with making tough financial sacrifices on a daily basis. The district website says, "Paterson - A Promising Tomorrow. Together We Can." I'm asking you to please live by that. Please give us the support we need, both in and out of the classroom. Please, let's work together and come up with a contract soon. Thank you for your time.

Ms. Rosemary Chichester: I'm a 26-year veteran teacher and I'm asking you to please settle our contract now.

Ms. Marlo Cozart: I'm honored and glad to be here. I've been a Paterson School District social worker on the child study team for the district for over 23 years. I would love to tell everybody how great we are, but it's hard to do that if we don't settle our contract. Please do so. Thank you so much for listening. Have a great day.

Ms. Monifa Mears Greer: I've been working for the Paterson School District for 21 years and it's been a struggle. This year I've been truly beaten down. I'm feeling a little

Be human about it. It is what it is. This is life and we just have to go about it and settle the contract. Be fair. It's the holiday season. Happy holidays! Be safe. Take care of one another. Let's get it done. Let's work together people.

Ms. Vivian Figueroa: Good evening. Paterson Public School teachers need a new contract. The children in our community deserve a better education with enough staff to serve them. Please. We need to settle the contract now. We need respect. Thank you.

Ms. Betsaida Morillo: I'm a Paterson school teacher. I've been in Paterson now for 25 years. This is the worst I've seen it as far as morale with the staff. We show up to work. Our students are suffering. The staff is suffering. Not only did Ms. Shafer get raises, the other superintendents got raises as well. Stop the blame game. Work together. We deserve respect. We work hard for our students. All we want for Christmas is an equitable and fair contract. Please give us what we deserve. Thank you and have a good night.

Ms. Jeannette Sosa: My name is Jeannette Sosa. First, my condolences to the family that lost a child. I will keep you in prayer. Congrats to the fabulous chorus presentations and the student going to Brown. I'm excited for that. I'm an ESL special education 19-year highly effective veteran teacher. I live and work here in Paterson and my children attend our public schools here. I vote here. I stand in solidarity with my fellow colleagues. Settle the contract now. We go above and beyond. We spend our

It's gotten so bad that I now have a class that I haven't been trained for. It's essentially an ESL class and I'm an art teacher. I've been teaching six classes without extra pay. This discussion about adding more classes, I've been doing it since 2001. I'm asking that you give us the respect that we give our students, our colleagues, and the district. Give the veteran teachers the dignity that they deserve. Thank you very much. Please settle the contract.

It was moved by Comm. M. Martinez, seconded by Comm. Redmon that the Public Comments portion of the meeting be closed. On roll call all members voted in the affirmative. The motion carried.

#### OTHER BUSINESS

Ms. Shafer: I want to thank everyone who spoke tonight and came to the meeting. The last contract was settled within 90 days of my arrival as Superintendent and approved by this Board. In addition to that, Board members were at the table of that contract. Nothing has changed. Both the Board and the administration care and respect our students and staff and we want to settle the contract, but it takes both sides to come to the table and negotiate. We look forward to the next meeting with the mediator. Please come to negotiations so we can settle the contract. Thank you, Mr. President.

Comm. Simmons: Is there anything anyone wants to add before we proceed to close?

## ADJOURNMENT

It was moved by Comm. Redmon, seconded by Comm. M. Martinez that the meeting be adjourned. On roll call all members voted in the affirmative. The motion carried.
