BREAKOUT GROUPS EXERCISE

Reflective Question: "What is Your Greatest Hope and Fear About the Governing Team's Ability to Ensure All Students Receive the Best Educational Experience in the Paterson Public School System?"

- **Group 1** – Fears the political influence/pressure that comes from outside and impacts the students and the district. Hopes to continue to advocate and push back against that negative influence for the benefit of the children.
- **Group 2** – Fears the role of politics and how it prevents the students from receiving the programs they need. Students are not always consulted about the programs they might be interested in receiving. Hopes that the administration will do a better job at hearing students' concerns and that the Board begins to act to benefit the students.
- **Group 3** – Fears that politics plays too strong a role in education. Hopes that political pressure decreases and becomes less of a factor in the educational decisions made.
- **Group 4** - Fears that the Board too easily applauds the presentations from the administration and their ability to produce positive educational outcomes. Hopes that the Board will better transmit to the staff its sense of urgency to produce educational results. Hopes that the Board improves in its ability to challenge what's being delivered educationally to the students.

Some Board members strongly feel that the students are not reaching high levels of academic achievement. It is not the Board's role to applaud the presentations of the administration, but to ask critical questions and hold them accountable for producing programs that truly address the educational needs of students.

Discussions are held in committees, but there is a lack of communication as to what specific questions were asked.

Board should develop process of communication that keeps everyone informed of the questions being posed to the administration.


