PRESENTATIONS AND COMMUNICATIONS

Introduction of High School Student Representative and Alternate to the Board of Education

Ms. Yaneliz Mejia: Hello everyone. Good evening. My name is Yaneliz Mejia. I'm currently a P-Tech student at PANTHER Academy. This summer I am very focused on my internship at IBM.

Ms. Shafer: If you want, you can read your bio.

Ms. Mejia: Perfect. I'm Yaneliz Mejia. I was born on January 6, 2005, in Jersey City, New Jersey. At the age of two, I moved to Paterson, New Jersey with my parents, Robinson and Yesenia. My mother is Puerto Rican, and my dad is Dominican. I am their firstborn. I have three younger brothers and an older brother. I am the only girl in the family. I come from a multicultural family. We are proud of our heritage. At the age of three, I attended Barney Day Care in Downtown Paterson. I attended there until I went to first grade. I attended School No. 18 until the sixth grade. After that, I went to John P. Holland Charter School and graduated on the Honor Roll and received a diploma for graduating my eighth-grade year. During my middle school years, I was chosen to attend the science fair and was awarded first place. Progress and success became my educational priority. I feel progress and success are very important, especially because being an outstanding sister and role to my brothers and being the best, I can be for my parents. Welcome to high school where all the excitement starts! Getting accepted to P-Tech at PANTHER Academy was a goal I achieved. Starting my freshman year was amazing. I met with IBM professionals who taught us about their experience at IBM, as well as going through hands-on projects that demanded we find the solution. I also took a code stream course and was on NBC New York News controlling robots on coding. This year, I committed to attending College Bound at Passaic County Community College during my high school career. During my freshman year, I played softball at Eastside High School, and I was also an Honor Roll student. Unfortunately, COVID-19 cut my freshman year short. I was virtual until school ended. Among the colleges I intend to apply to are Columbia University and Rutgers University. One day I hope to go to medical school and become a future anesthesiologist. I look forward to working with our new student representative to the Board, Yaneliz Mejia, as well as the Board of Education Commissioners and district administrators. I thank you for this opportunity to serve the students of the Paterson Public Schools. I wish you all a happy school year.

Ms. Shafer: That completes my report for right now. I would like to come back on after the resolutions are voted on.

REPORT OF THE PRESIDENT

Comm. Teague: I did speak with the President tonight, and he has tried to work out having a joint meeting between us and the City Council. Right now, we're just waiting on confirmation from the City Council President in terms of when we're going to be able to actually sit down and have a joint session. That's in the works.

PUBLIC COMMENTS AND HEARING ON THE CONTRACTS FOR ASSISTANT SUPERINTENDENTS AND BUSINESS ADMINISTRATOR

It was moved by Comm. Simmons, seconded by Comm. D. Martinez that the Public Comments portion of the meeting be opened. On roll call all members voted in the affirmative. The motion carried.

Ms. Rosie Grant: Good evening, everyone. Thank you for this opportunity. I don't comment on the specifics of contracts. As Executive Director of Paterson Education Fund, I know that we have competent and qualified individuals in place. My only plea to you is in your deliberations on this subject and whatever the subject is to remind yourself to ask how it serves our children. When we can answer that question and it's positive, we know that we have made the right choices and decisions. That is my ask of you this evening as far as the contracts. Thank you so much.

Ms. Tina Tarakji: My name is Tina. I'm a resident of Paterson. I've lived here my entire life. I'm speaking on behalf of my son, Major Jones. He's a five-year-old disabled child who is homebound. He is vented 24/7 and he has a G-Tube. He also suffered a brain

injury back in 2019. I'm having a real big problem with getting my son the services he is entitled to. I've been fighting with the Board of Education for three years now with getting him in-home services for physical and occupational therapy. My son has not been medically cleared by any doctors to go into a school, nor do we feel comfortable sending him into a school being that he's so medically challenged. I've been in conversations with out-of-district social workers. I'm not even sure why they have pushed me to an out-of-district social worker. We were virtual the first and second years, but why are we virtual going on three years? Why isn't the Board opening the meetings up where families and people like me can come down and speak to you guys face-to-face? We can show you, our children. We can look you in the eyes and tell you our stories face-to-face. Why isn't anything opening? Why is the school year going virtual again? Unless you're a parent of a child like mine, you wouldn't understand. It's a medically bound child that needs to be home. Why aren't they receiving PT and OT at home when other districts are providing it? Why are we being forced out of district into other schools and forced into sending our children to other schools when they aren't medically safe to be in schools? My son cannot sit in a wheelchair for more than one hour. He has 80-degree scoliosis. He cannot withstand sitting in a wheelchair or being in any type of back brace for that long.

Comm. Teague: Fortunately, the Superintendent is going to address this. As a Board member, I can't speak to that.

It was moved by Comm. Hodges, seconded by Comm. Redmon that the Public Comments portion of the meeting be closed. On roll call all members voted in the affirmative. The motion carried.

BOARD COMMENTS

Comm. Teague: I do know that several of my colleagues have some comments or questions about the contracts for assistant superintendents and business administrator. I'm going to open the floor for you at this time.

Comm. M. Martinez: Keeping in mind what Rosie had alluded to being that the nature of this discussion is contracts and personnel, there are some areas where we have to be very careful about what we do and do not discuss. Just for public edification, what was the intent of a public hearing? What is going on with the contracts of the assistant superintendents and the business administrator that need to be...

Comm. Redmon: Hold on one second.

Comm. M. Martinez: I didn't finish my question.

Comm. Redmon: I know you didn't. Hold on. I just have to be careful because we didn't rice the superintendents. We have to make sure that we do not discuss their names.

Comm. M. Martinez: I purposefully did not mention names. I'm mentioning positions.

Comm. Redmon: I just wanted to make sure that we were all on the same page.

Comm. M. Martinez: I appreciate that. Thank you for that clarity. Mentioning positions, what was the need to hold a public discussion about these positions? What is in question? Why is there a need to discuss this? That's the first layer of my question.

Ms. Shafer: Any time that you are changing someone's contract, but not just the finance piece, but to the terms and conditions, you need to have a public hearing. The terms and conditions have changed with these positions because we are eliminating longevity.

Comm. M. Martinez: Not sure how much in detail we can go. Is longevity the only element of their contract that is being changed?

Ms. Shafer: That's correct.

Comm. M. Martinez: To the extent to which we are able, what is the reason for changing longevity?

Ms. Shafer: Because we are not competitive within Passaic County or like districts in the State of New Jersey. We are on the very low end of the spectrum. In order to make these folks whole, we eliminated longevity and put it in their salary. We also did right-sizing to get them to be a little more competitive for districts like ours that are large.

Comm. M. Martinez: That's to say to some extent that the positions that we're discussing are on a county level underpaid as compared to other folks who hold the same positions?

Ms. Shafer: Yes, throughout the county and also other districts that are large like we are.

Comm. M. Martinez: You said it makes them whole. By eliminating the longevity, how does that make them whole? How does that affect the whole process and them in that position?

Ms. Shafer: The longevity increased the salary. Then they had their annual raise. Some had what's called right-sizing to get them to be in a more competitive position within the county, the State of New Jersey, and districts as large as ours.

Comm. M. Martinez: The removal of the longevity gets baked into their contract. Without numbers, that's to say that their base salaries will increase to some extent.

Ms. Shafer: That's correct.

Comm. M. Martinez: Any adverse fallout from the elimination of longevity? Is this only occurring with the positions that were put forth?

Ms. Shafer: It's only for the positions that were put forth. Not everyone was in agreement to eliminate longevity, but the majority was.

Comm. M. Martinez: I'm not familiar with the intricacies of such a move. What would be the flip side of not removing the longevity? What would be the counterargument to that? You said some folks were not in favor. What was their position?

Ms. Shafer: They wanted to keep accruing longevity.

Comm. M. Martinez: What would be the benefit of doing that as opposed to what we're doing?

Ms. Shafer: Each year you would continue to get longevity. Now, whatever your longevity is, it was baked into your base salary.

Comm. M. Martinez: So, it could be that in the immediate their contract would be bumped up slightly or whatever, but long-term they're missing out on that longevity?

Ms. Shafer: They could miss out on that total longevity package.

Comm. M. Martinez: Short end, they're going to get a bump, but long end, it could be a hit for them.

Ms. Shafer: That's correct.

Comm. M. Martinez: I can understand why some folks would be against that.

Ms. Shafer: Keep in mind that they also got the right-sizing amount of money that would put them in a position that would be more competitive in the county and districts that are similar in size to ours.

Comm. M. Martinez: Right-sizing, in this context, is essentially putting their salaries more on par with the salaries of others in the county who have those same positions.

Ms. Shafer: Correct, and also in other districts that are the same size as us.

Comm. M. Martinez: Okay, thank you.

Comm. Teague: Are there any other questions?

Comm. M. Martinez: This will be voted on in personnel?

Ms. Shafer: No, this is the public hearing.

Comm. M. Martinez: Not today, but at the regular meeting.

Ms. Shafer: That's correct.

Comm. M. Martinez: Thank you.

REPORT OF THE SUPERINTENDENT

Ms. Shafer: I wanted to address two items. One was the parent who spoke in the public portion. I'm going to ask Cheryl Coy to comment about the concern that the parent has with home instruction and services provided in the home.

Ms. Cheryl Coy: Due to confidentiality for a student, we can't discuss details. There have been communications and we will continue to follow up with the parent to come to a resolution that's in the best interest of the child. At this time, the district does not have in-home services for home instruction, whether it be a teacher for instructional, or related services. We will continue to work with the parent to come up with a resolve.

Ms. Shafer: Is that due to COVID?

Ms. Coy: Due to COVID and now with the Monkeypox coming in, we have not had anyone returning to the homes.

Comm. Hodges: Is this the situation across the state? Or is this just occurring in Paterson?

Ms. Coy: I can't answer on other districts. I'm not certain. That is the protocol that we have been following since the pandemic. There are other options. I just can't disclose them because it would breach confidentiality for the child and family.

Comm. Teague: Has there been a lift date on this in terms of when staff would be able to return to homes?

Ms. Shafer: We have been watching the positivity rate. I receive it from St. Joseph's Hospital every day. It is high all over the State of New Jersey right now. At this point, I can't tell you when we will have teachers and service providers going into homes. It's to protect the child and the family, as well as the staff. We don't want to bring it into the home and we also don't want staff members infected. We continue to watch the positivity rate.

Comm. Teague: Did you want to address the resolutions?

Comm. Capers: Are we looking to put something in place to see vaccinated versus unvaccinated? If the teacher and all the family members are vaccinated, can they go into the home?

Ms. Shafer: We can certainly look at that. Right now throughout New Jersey there's a high positivity rate. It changed over the past two to three weeks and that's why we're closely watching it. We want to make sure we get kids back in school. I'm not opening schools up for outside groups at this point. We're going to continue to look at that because we're trying to keep instruction with a teacher in front of the kids in the physical classroom. That's my priority right now.

Comm. Hodges: If that rate continues high will we go back to wearing masks?

Ms. Shafer: Yes, we probably will.

Comm. Teague: Tonight there was also an issue raised about the meetings still being virtual. I'm guessing that will probably continue if numbers continue to go up. I did hear a parent question that tonight. I'm guessing that falls under the same category.

Comm. Simmons: That's going to be an internal discussion with the Board. Where we would normally meet for this meeting, we can't meet in that space right now. Then we'd have to figure out some other logistics on how and where we meet.

Comm. M. Martinez: That was a question I wanted to follow up on too. I've been receiving calls wondering why we haven't been meeting in person. It's been years now that we haven't met in person. I think it's high time we address that because folks have been asking about that too.

Comm. Teague: Yes, indeed.

Ms. Shafer: I also want to remind everyone that even if you've vaccinated, you don't stop the spread. There are many people who are vaccinated and boosted who have gotten COVID and have gotten it pretty good. Now it's at an all-time high. I think we need to continue to watch it. Like I said, my priority is to get the students and the staff back into the classroom in a safe environment. I wanted to wait until the personnel resolution was approved. I'd like to introduce to the staff and the Board Commissioners a new Associate Chief of Technology in MIS. You all know that we had gone out looking for an associate chief of technology in MIS services. We also had the passing of Chris Lewis. In addition to all that, we've added about 32,000 devices to the district plus Promethean boards in every classroom and every building. That installation is happening as we speak. I am pleased to introduce and welcome aboard Mohammed Saleh. I'm going to ask Mohammed if he would introduce himself and say a few words.

Mr. Mohammed Saleh: Good evening Superintendent Shafer, Deputy Superintendent Peron, cabinet members, and Board Commissioners. My name is Mohammed Saleh. I want to thank you all for this opportunity. I'm very excited to serve and provide technical services to the faculty, staff, families, and students of Paterson Public Schools. With over 15 years of experience in educational technology infrastructure, working in various schools in Northern New Jersey, I'm thrilled to bring my knowledge and experience to Paterson. Thank you all for this opportunity. It really means a lot to me.

Operations

Comm. Arrington: Operations met today. Present was myself and Comm. Capers. We also had Assistant Superintendent Cozart, Ms. Vainieri, Mr. Fields, and Ms. Brown. I look forward to having them and I welcome them once again. I'm looking forward to working with our student representatives.

Comm. Hodges: President Simmons, how will they get that information back to the different schools?

Ms. Shafer: We have put together a form for the student representatives which mimics the Board agenda, items for discussion, and new business. It's going to work two ways. They will complete the forms and that information will go to all of the student government officers at every high school. At every high school, the student government officers will collect any student issues, concerns, or suggestions they want to bring to the Board. Let's say that at Kennedy High School the kids want to have pizza three days a week. They would bring that to have a discussion with the Board as to whether or not that is something that the Board would consider. It will be back-and-forth communication. They will fill out the form, email it to their officers in all the high schools, and then those officers have meetings with the student body, and they will go over that information at their meetings. At the same time, they will be gathering information, questions, or concerns that they can bring forward to have the Board listen and have a discussion around.

Comm. Hodges: Will that student meeting be at the high school level?

Ms. Shafer: Yes.

Comm. Hodges: All the high schools will be meeting with these leaders on a regular basis.

Ms. Shafer: These leaders will be sending to the president, vice president, secretary, and treasurer all the SGA officers in every high school. They will get their notes and will have a communication going on with all of them. Then the individual SGA officers will
