 - 1. Approve implementation of the Education & Training III curricula for grades 9-12, for the 2021-2022 school year. **APPROVED**
 - 2. Approve implementation of the revised curriculum for Advanced Placement (AP) courses AP Biology, AP Calculus, AP Language and Composition, AP Literature and Composition, AP Research, AP Seminar and AP Spanish Language & Culture, for the 2021-2022 school year. **APPROVED**
 - 3. Approve adoption of the Nursing Services Plan pursuant to N.J.A.C. 6A:16-2.1(b), for the 2021-2022 school year. *APPROVED*
 - 4. Approve entering into an agreement with Northern Regional Education Services Commission to provide nursing services to four non-public schools, for the 2021-2022 school year, in the amount of \$29,456.00. **APPROVED**
 - 5. Approve the purchase of 12,500 ALEKS licenses and PD services, a Webbased, artificially intelligent assessment and learning system from McGraw Hill, that uses adaptive questioning to quickly and accurately determine the student's current level of mastery, determine an individualized path for each student to achieve 100% mastery of course content, instruct the student on the topics they are ready to learn, and reassess the student to ensure that topics are retained, for all middle school and high school students, for the 2021-2022 school year, at an amount not to exceed \$213,125.00. **APPROVED**

Approve entering into a contract with Teaching Strategies, LLC, The Creative Curriculum Cloud, for the purchase of digital curriculum resources and planning tools that help to individualize instruction, facilitates communication between teachers and families, streamline weekly planning processes, and offers access to new family-facing resources to build consistency in learning experiences, for all preschool staff and families, for the 2021-2022, 2022-2023, and 2023-2024 school years, at a total amount not to exceed \$208,800.00. **APPROVED**
- 7. Approve entering into an agreement with Students2Science Inc., to provide virtual lab workshops to middle and high school students to explore and deepen their awareness of STEM careers, in accordance with the New Jersey Student Learning Standards for Science (NJSLS-S), for the 2021-2022 school year, at an amount not to exceed \$40,000.00. **APPROVED**
- 8. Approve implementation of the Morning Mindfulness and Tutoring Program at School No. 16, to provide students with a before-school program to provide tutoring to students that struggle in Language Arts and Math, and provide all students the opportunity to participate in morning activities that engage them in character development that will support their social-emotional development and increase their self-regulating and decision-making skills in order to be the leaders in actualizing 21st Century skills, for the 2021-2022 school year, at an amount not to exceed \$25,840.00. **APPROVED**

Approve implementation of the BrainPop pilot program for students in grades K-8 to have the ability to interact with universal global topics engaging students in learning content through interactive games, animated movies and activities, for the 2021-2022 school year, at no cost to the district. **APPROVED**

Approve entering into an agreement with Montclair State University Strategic Prevention Framework Partnership for Success Initiative/SBIRT for staff trainings and student data collection, to provide motivational intervention to students on the topic of mental wellness and substance use, abuse and misuse, for the 2021-2022 school year, at no cost to the district. **APPROVED**
- 11. Approve acceptance of the Nonpublic Security Aid funding to help ensure a safe and secure school environment for nonpublic school students at Gilmore Memorial Christian Academy, Compassion House Ministry, Dawn Treader Christian School and St. Gerard School, for the 2021-2022 school year, in the amount of \$46,025.00. **APPROVED**
- 12. Approve acceptance of the Nonpublic Technology Aid funding to provide computers, educational software, distance-learning equipment, and other technologies at Compassion House Outreach, Dawn Treader Christian School, Gilmore Memorial Christian Academy and St. Gerard School, for the 2021-2022 school year, in the amount of \$11,046.00. *APPROVED*
- 13. Approve attendance for two (2) board and staff members to attend conferences/workshops, at a total amount of \$2,676.00. **APPROVED**
