Approve submission of an application to the New Jersey Child Assault Prevention (NJ CAP) Program, to provide a series of workshops for staff, parents, and students to assess the specific nature of bullying in the schools, to train adults in appropriate intervention strategies, and to improve student interaction, for Grades PreK-6, funded through the NJ Department of Children and Families, at no cost to the district. **APPROVED**
