New Jersey Department of Education's enrollment numbers, School 28 is reported as a pre-k through eighth grade school and it's a pre-k through first grade school. It's my understanding that gifted and talented is a separate school. So, I'm just wondering why they're listed as one school as opposed to two separate schools. Also, when I disaggregated the data and I broke it down from pre-k to one and then 2-8, my numbers for gifted and talented were 284. However, in their presentation they reported only 223 students. That's a difference of 60 kids. I wasn't aware of that when I sent my email so I just wanted to bring that forward. If there's anything you can do to make sure the conversation takes place, I would appreciate it and it would show that there's intent in a resolution. I think it's called for. I think the children of Paterson, especially the children that are possibly overlooked, deserve it. Also, I'm going to start looking into criteria into the different schools, like School 1, Alexander Hamilton and Norman S. Weir. When you look at the data on the demographics it's clear that there's segregation along class lines and a number of things going on. I'm looking to start that conversation as well. Thank you.

OTHER BUSINESS

Comm. Hodges: Before you adjourn, I sent Cheryl a copy of a video aimed at Dr. Evans, Ms. Peron and the science department. I think it's Japanese and they have found a way to grow a chick embryo in a plastic enclosure so that you can visualize the entire process. I think it would be a wonderful opportunity for our students and it doesn't involve a whole lot of... It's apparently very inexpensive from what I can see from the video and you can go online and find it. You can study the embryology and the development. Something like that was done in this country more than 55 years ago, but we actually killed the chicks in various stages of their development. Here you don't have to kill it at all. You just have to watch the whole process unfold and I think it would be something that we should look into doing. I'm going to send it to the whole Board. I managed to finally get it online and I'll send it to the whole Board so you can see the actual video. It's rather impressive and it's cheap, or relatively inexpensive. It's something that we need to start to look at to help excite students about science.
