 - On **Tuesday, September 3**, 10-month instructional staff will gather at the Howard D. Mettelman Learning Center. Light refreshments will be served from 7:30-8:00 a.m., followed by a short welcome message. The day's meetings and the agendas, provided by your Department Supervisor or Principal, will commence immediately after.

Mandated Trainings (Virtual)

All staff members will have access to the annual mandated trainings beginning on **Monday, August 26**. The mandatory trainings will take approximately 3 hours to complete, and it is **required** that all staff members complete the trainings, during work hours, no later than **Friday, September 6**. An email including a link to the trainings with your login credentials and instructions will be sent to you later this week. **Time will be provided for you to complete the mandatory trainings between August 26-September 6, 2024.**
