



REQUIRED RESIDENCY INFORMATION

If **OWNING** a residence in Lee County AND residing in that residence:

- (1) **Property Tax Bill or Mortgage Statement** in your name showing property address.
AND
- (2) **Current Electricity Bill** (GA Power/ Mitchell/ Sumter EMC) in your name showing the property address, service address, & wattage used.
AND
- (3) [Residency Affidavit for One Student](#) or [Residency Affidavit for Multiple Students](#)*
If the electricity bill is NOT in your name (*friend/ family member*), the parent/guardian must also **Supply 1 Bill** (*cable/water/home-owner's insurance, credit card, doctor bills, bank statement, car insurance, or pay stub*) in the parent/ guardian's name with the Lee County address.

If **RENTING** a residence in Lee County AND residing at that residence:

- (1) **Complete Copy of the Current Lease/Rental Agreement** that is signed and dated with ALL household members included on the lease or addendum.
AND
- (2) **Current Electricity Bill** (GA Power/Mitchell/ Sumter EMC) in your name showing the property address, service address, & wattage used. (*If the electric service is included in your current lease agreement, you must provide satisfactory evidence that it is included, such as a notarized statement from the landlord.*)
AND
- (3) [Residency Affidavit for One Student](#) or [Residency Affidavit for Multiple Students](#)*
AND
- (4) **Supply 1 Bill** (*cable/water/home-owner's insurance, credit card, doctor bills, bank statement, car insurance, or pay stub*) in the parent/ guardian's name with the Lee County address.

**Link provides access to the appropriate LCSS Form. If needed, the System Registrar can also provide a hard copy of the form. A Notary Public is available at the System Registrar's office for affidavits signed at the office. No affidavit will be notarized by the system's Notary Public unless the signature on the form is witnessed.*

If **SHARING** a residence in Lee County with another individual/family and have no bills related to the household expense:

- (1) **Property Tax Bill or Mortgage Statement or Complete Copy of the Current Lease/Rental Agreement** signed and dated with ALL household members on the lease or addendum.
AND
- (2) [Homeowner Residency Affidavit](#)*
AND
- (3) [Residency Affidavit for One Student](#) or [Residency Affidavit for Multiple Students](#)*
AND
- (4) [Shared Housing Form](#)*
AND
- (5) **Current Electricity Bill** (GAPower/Mitchell/ Sumter EMC) in homeowner/authorized tenant's name showing property address, service address, & wattage used (*Electric service included in the current lease agreement? Provide satisfactory evidence - notarized statement from landlord*)
AND
- (6) **Supply 2 Bills** (*cable/water/home-owner's insurance, credit card, doctor bills, bank statement, car insurance, or pay stub*) in the parent/ guardian's name with the Lee County address.

<i>*The person enrolling the student must have guardianship of the student if the person is not the student's biological/adoptive parents, and proof of guardianship through the Superior Court of Lee County must be provided (guardianships must be approved by the System Social Worker). If the biological father is enrolling the student, and was not married to nor divorced from the mother of the child, court papers must be submitted showing the father as the legal custodial parent of the child.</i>	
<i>**Each person's respective award of physical custody must be identified in the decree. The school system must be informed of any changes to the court order immediately. Students must be enrolled in the school in the county/zone where the custodial parent resides.</i>
