Sharp Creek's Blue Norsebots Headed to World Robotics Championship

The Sharp Creek Robotics Team A – the Blue Norsebots. Team members Lyla Bretzman, Noah Ross, Hudson Texeria, Audrey Willett, Gabriel Hyden, and Hunter Travis have earned an invitation to compete at the VEX Robotics World Championship in Dallas, Texas this May—The Sharp Creek Norsebots are the ONLY Public School in Northern Indiana to earn a spot at the Elementary VEX robotics World Championships.

This year's competition, Rapid Relay, is a fast-paced robotics challenge that resembles basketball, requiring strategy, speed, and precision. The Blue Norsebots stood out with their innovative engineering, including a custom-designed pneumatic flipper that transfers balls between a high-goal and low-goal shooter. No other team in Indiana has a design like it, and it was this originality and ingenuity that earned them the Innovate Award at the Indiana State Championship—one of only seven judged awards that secured a spot at Worlds.

Out of over 1,000 elementary teams in Indiana, all four Sharp Creek teams advanced to the state championship, placing them in the top 122 teams in the state. The Blue Norsebots went on to finish an impressive 8th place overall at state, capping off an already incredible season.

During the regular season, under the expert guidance of Coaches Kevin and Amber Bretzman and Joel Nesler, the Blue Norsebots also brought home an array of awards:
