5.1 **Item: 25-048 – LCAP**

5.2 Item: **25-049 – 12 Month Employees, 4-10 Hour Work Week**

Discussion: Annually to save costs on air conditioning and electricity, the District is requesting that the board approve 12 month staff to work 4, 10 hour days effective June 23 through August 1, 2025. Staff would return to 5, 8hour days on August 4, 2022. The office will be open from Monday through Thursday and will be closed on Fridays.

Recommended Action: Approve the 12 month staff work schedule change from 5 days/8 hours per day to 4 days/10 hours per day effective June 23, 2025 through August 1, 2025.

5.3 Item: 25-050 - Resolution 25-006 Senate Bill 1315 Small School Districts

Discussion: Fall 2024, the Governor signed Senate Bill 1315, amending Section 33318.2 of the Ed Code & Section 9795 of the Government Code, requiring the CDE to submit a report by 3/1/2025, identifying all Local Education Agency reporting

requirements, specifying the purpose of each, and making recommendations for the consolidation and/or elimination of those requirements. It is imperative for the health of California's educational system that the burden of reporting be reduced for school districts serving fewer than 2,500 students, with flexibility, exemptions, or abbreviated reporting formats provided to small LEAs.

Recommended Action: Review and approve Resolution 25-006. This resolution be shared with the California School Boards Association for transmittal to the California State Legislature.

5.4 Item: 25-051 – Resolution 25-008 Supporting Education Workforce Housing Legislation AB 1021 & AB 1381

Discussion: California's housing shortage hinders the state's ability to cultivate and maintain a high-quality education workforce. Supporting AB 1021 and AB 1381 urges the Legislature and Governor to support these important measures to help address the state's education workforce shortage crisis.

Recommended Action: Review and approve Resolution 25-008. This resolution be shared with the California School Boards Association for transmittal to the California State Legislature.

5.6 Item: 25-053 - Designation of RVUSD BOE Member(s) to hand out 8th Grade and High School Diplomas

Discussion: The high school graduation will be held on Friday, June 13th at 6:00 p.m. The 8th grade graduation will be held on Thursday, June 12th, at 6:00 P.M. Board members are needed to participate in the graduations to hand out diplomas and certificates. The Board is requested to determine those members who will participate in each graduation.

5.7 Item: 25-054 - California Interscholastic Federation - Record District and/or School Representative to Leagues

Discussion: The education code gives the authority for high school athletics to high school governing boards. The code requires that after joining CIF, local school boards are required to designate representatives to CIF. (Ed. Code 33353 (a) (1)).

Recommended Action: To appoint Jobe Thomson, Amy Tillotson and Amanda Derby as CIF League Representatives

5.8 Item: 25-055 – Board Policy 4127 update with language addition

Discussion: The board policy 4127 regarding Temporary Athletic Team Coaches should provide for all other non-certificated staff to have preference to any open coaching position above any non-staff. The current standing MOU with CSEA (signed and dated August 15th of 2023) is basis for the addition.

"If the coaching position is not filled by a certificated employee the position shall next be made available to any non-certificated employees of the district."

5.10 Item: 25-057 – 2024-25 Second & Third Quarter Uniform Complaints Report (Williams)

Discussion: Under William's legislation, the district is required to report quarterly to the state regarding the number of complaints that the district has received in writing for the following:

1) sufficiency of textbooks and instructional materials; 2) teacher vacancies or misassignments;

3) condition of facilities; and 4) support for students who must pass the CAHSEE. The first quarter Williams Uniform Complaint Procedures (UCP) Report lists no complaints.
