#### Public Participation

- 3. No participant may speak more than once on the same topic until all others who wish to speak on that topic have been heard; and only then if time constraints and/or the presiding officer allow.
- 4. All statements, questions, or inquiries shall be directed to the presiding officer; and any questions or inquiries directed by a participant to another Board member or Superintendent shall be redirected to the presiding officer who shall determine if such statement, question, or inquiry shall be addressed by the presiding officer on behalf of the Board or by the individual Board member or Superintendent;
- 5. It is the expectation of the Board that communications between participants and the Board will remain positive and focused around the best interest of the student(s) and the district as a whole. All communications from all stakeholders shall be conducted with mutual respect and civility. The Board will not condone communications and interactions that can be perceived as harassing, insulting, threatening, or lacking in respect or civility.

The presiding officer may:

- a. Interrupt, warn, and/or terminate a participant's statement, question, or inquiry when it is too lengthy;
- b. Interrupt and/or warn a participant when the statement, question, or inquiry is abusive, obscene, or may be defamatory;
- c. Request any person to leave the meeting when that person does not observe reasonable decorum;
- d. Request the assistance of law enforcement officers in the removal of a disorderly person when that person prevents or disrupts a meeting with an act that obstructs or interferes with a meeting;
- e. Call for a recess or an adjournment to another time when the lack of public decorum interferes with the orderly conduct of the meeting; and
- f. Waive these rules when necessary for the protection of privacy or to maintain an orderly operation of the Board meeting.

The submission will basically highlight the district's exemplary programs and services for our students with special needs.

## SUPERINTENDENT'S REPORT

- Celebrated the achievements of the students recognized at the meeting, emphasizing the district's commitment to student success.
- Praised the hard work of students and advisors preparing for the Cedar Drive Middle School (CDMS) production of Matilda. As Mr. Walsh reported, the Senior Citizens are invited to attend the dress rehearsal as a special event.
- CDMS 60th Birthday Celebration will be held on April 24th, 6-8 p.m. A student-led "time travel" walk will take visitors through the school's history. A formal program from 7-8 p.m. will feature performances by singers and the band, along with appearances from alumni. Board member Mr. Orrico may make a special appearance.
- 2025 Read-a-Thon participants collectively read over 250,000 minutes a milestone achievement. Fundraising efforts were successful, and top readers and fundraisers will receive medals. New families broke past participation records.
- During Read Across America Week, students chose from donated books. Unsold books were donated to the American Red Cross Food Bank at Naval Weapon Station Earl in partnership with the school's liaison.
- The Parent Academy is scheduled for April 7th, 10 a.m. at the Administration Building and will focus on K-5 Math and Language Arts. The academy will be live-streamed and recorded for later viewing. It has a capped in-person audience of 20 attendees.
- NJSLA 2025 Testing is scheduled for May 6th May 20th. Parents will receive detailed information in a letter from Dr. Reynolds, the Director of Curriculum and Instruction. Participation is encouraged as it provides a comprehensive view of student performance and affects the district's performance reports. The district respects parents' rights to refuse testing but emphasizes the value of participation for state evaluations.

President Volpe inquired whether higher participation helps with the district's efforts

in obtaining Blue Ribbon status? Dr. Garibay responded that the more students who take it increases the percentages, so it could potentially help.

- At the April 8th Board of Education meeting, she anticipates recommending a proposed amendment to the current 24-25 school calendar. This year's calendar includes three emergency days that are built in for snow, which have not been used. Those three days are in excess of not only the teachers contract, but also our contract. It is likely and very tentative, but she will look to end school on the 20th and then possibly give back the last day in May, possibly the day before Memorial Day weekend.
- Noted on the agenda this evening is the approval of the Memorandum of Agreement between the Board of Education and Law Enforcement Officials.
- The Tentative Budget is on the agenda for adoption and includes a general fund zero % tax levy increase.
- Provided clarification regarding Finance Item #8 which is the approval of the Travel and related expense reimbursement resolution. This is an annual requirement per the fiscal accountability, efficiency, and budgeting procedures in Chapter 23A of Title 6A New Jersey Administrative Code, specifically 6A 23-A-7.3, which requires that annually in the pre-budget year, each district BOE shall establish by resolution a maximum travel expenditure amount for the budget school year, which the school district shall not exceed. The resolution shall also include the maximum amount established for the pre-budget year and the amount spent to date.
- Policy 8820, Opening Exercises is up for adoption this evening. This policy, as Mr. Scales and the members of the Board have discussed, is an addition of the Star Spangled Banner at the start of each school day. This will be communicated to families.
- Recognized Ms. Leigh Farran who is retiring from the district after seven years of service as a kindergarten assistant, wished her the best of happiness, health, and a lot of laughter as she goes into her retirement.

# 8. TRAVEL AND RELATED EXPENSE REIMBURSEMENT FOR 2025-2026 SCHOOL YEAR

BE IT RESOLVED that the Colts Neck Township Board of Education approves the following resolution:

WHEREAS, the Colts Neck Township Board of Education recognizes school staff and Board members will incur travel expenses related to and within the scope of their current responsibilities and for travel that promotes the delivery of instruction or furthers the efficient operation of the school district; and

WHEREAS, N.J.A.C. 6A:23A-7.2 et seq. requires Board members to receive approval of these expenses by a majority of the full voting membership of the Board and staff members to receive prior approval of these expenses by the Superintendent of Schools and a majority of the full voting membership of the Board; and

WHEREAS, the Colts Neck Township Board of Education has established \$46,461 as the maximum travel amount for the current school year, and has expended \$13,423 as of this date;

NOW, THEREFORE, BE IT RESOLVED, that the Colts Neck Township Board of Education approves travel and related expense reimbursements in accordance with N.J.A.C. 6A:23A-7.3, to a maximum expenditure of \$45,724 for all staff and Board members for the 2025-26 school year.

## DISCUSSION:

Mrs. Camera requested clarification on budget transfers and why they are done each month. Mr. Marasco noted that budget changes throughout the year are a given and therefore budget transfers are necessary, which are allowable and governed under Title 18A. Dr. Garibay used the transfer of funds to purchased services for substitute aide coverage for an autism class as an example, explaining that due to recent resignations of instructional assistants, the district still needed to provide legally required services for students with IEPs (Individualized Education Programs). In the absence of replacements, these services were contracted out, which often comes at a different cost than employing substitute instructional assistants. Since accounts cannot be overextended on a monthly basis, the district must reallocate funds through budget transfers.

Mr. Scales asked for clarification on the taxes to be levied for the budget, noting that the district is requesting \$24 million to balance the budget. He questioned whether the district plans to ask the town how the additional revenue from the recent 10% to 25% property tax increases will be used. Since the district's request remains the same as the previous year, he was curious if the town could provide insight on how the extra funds will be allocated. Dr. Garibay indicated that she has reached out specifically to the town council and to the Mayor, and is looking to set up a meeting in the near future to discuss that.
