- 4. All statements, questions, or inquiries shall be directed to the presiding officer; and any questions or inquiries directed by a participant to another Board member or Superintendent shall be redirected to the presiding officer who shall determine if such statement, question, or inquiry shall be addressed by the presiding officer on behalf of the Board or by the individual Board member or Superintendent;
- 5. It is the expectation of the Board that communications between participants and the Board will remain positive and focused around the best interest of the student(s) and the district as a whole. All communications from all stakeholders shall be conducted with mutual respect and civility. The Board will not condone communications and interactions that can be perceived as harassing, insulting, threatening, or lacking in respect or civility.

- a. Interrupt, warn, and/or terminate a participant's statement, question, or inquiry when it is too lengthy;
- b. Interrupt and/or warn a participant when the statement, question, or inquiry is abusive, obscene, or may be defamatory;
- c. Request any person to leave the meeting when that person does not observe reasonable decorum;
- d. Request the assistance of law enforcement officers in the removal of a disorderly person when that person prevents or disrupts a meeting with an act that obstructs or interferes with a meeting;
- e. Call for a recess or an adjournment to another time when the lack of public decorum interferes with the orderly conduct of the meeting; and
- f. Waive these rules when necessary for the protection of privacy or to maintain an orderly operation of the Board meeting.

# **REPORT OF PRESIDENT – Mrs. Heather Tormey**

PRESIDENT'S REPORT

Heather Tormey reported:

- Recognized that November 15th is Education Support Professionals Day. On behalf of the Board of Education, Mrs. Tormey extended sincere gratitude to the long list of professionals (administrative assistants, classroom aides, cafeteria workers, maintenance workers, and bus drivers) who keep Colts Neck schools running efficiently. She noted their daily contributions help make Colts Neck Township Public Schools exceptional for every child, so they can be safe, learn, grow, and achieve.
- The district held a Veterans' Day program on November 8th that engaged staff and students at all three schools as they recognized and honored local veterans, many of whom are related to our students or staff. The primary and elementary schools welcomed 29 veterans and attendees got to see a demonstration by the drill team from the award-winning and nationally recognized CNHS ROTC Program. Cedar Drive also hosted the ROTC unit for a demonstration, and a special group of veterans and their family members joined the celebration. This effort was coordinated through the efforts of district staff and their partnership with Colts Neck Township Recreation.
- The district held its second Parent Academy on November 2nd which highlighted the High School exploration process.
- Mrs. Tormey noted there is a Parent Academy session taking place tomorrow evening entitled "Count on Lit", with district Literacy Coach, Lysa Cook and Math Coach, Tina Kennis, from 7:00pm - 8:00pm at the Administration Building. Mrs. Cook and Ms. Kennis will share resources to help parents and caregivers of students in grades K-5 become full partners in their child's education. Signup can be found on the district website.
- Mrs. Tormey shared that Conover Road Elementary School and Cedar Drive Middle School were recognized in the US News Best Elementary and Middle Schools rankings, landing among the top 40% in the State. While the district remains committed to working towards further progress and growth for our students, the district is excited to celebrate this recognition.
- The Chorus program will be participating in the Colts Neck Tree Lighting on December 2nd at Town Hall, beginning at 4:30 pm. Mrs. Tormey thanked the music teachers for participating in this event along with our students.
- Mrs. Tormey shared that students at Conover Road Elementary School and Conover Road Primary School will be enjoying new, flexible seating as a result of the PTO Legacy Grant,. The flexible seating is for numerous classrooms and common areas; and teachers can designate times for students to utilize this new seating as another way to create unique spaces for students to learn and collaborate in their classrooms and schools.
- On November 2nd, Cedar Drive Middle School teacher Mr. Coe hosted a gathering for students to interact with professional women in STEM related fields

such as Oncology from Johnson and Johnson, a PhD student in Archaeological Anthropology from NYU, a PhD student studying reproductive energenetics in primates from NYU, the Chief of Pediatric Advanced Care at K Hovnanian Children's Hospital, an advanced practice nurse / Medical Director of the Regional Newborn Center at Monmouth Medical and a licensed psychologist specializing in children and young adults. Each of the highly accomplished women gave their time to our students, contributing to a wonderful learning experience. Mrs. Tormey thanked Mr. Coe for his continued efforts in providing students with STEM related learning experiences and professionals.

• Mrs. Tormey encouraged the community to come together in support of helping the WIIcox family. On December 5th from 6-9pm, Colts Neck will be hosting 'Rockin Hearts for Brady' with music by Colts Neck's own Mr. Willis. Attendees can purchase raffle tickets and 50/50 tickets. 

## NEW BUSINESS/WORK SESSION AGENDA

John Camera read from a prepared statement - He congratulated the four (4) winning candidates for their successful campaign to become members of the Board of Education. He stated he is looking forward to working with each new member and commended them on running a campaign which focused on their positions and the actions of the Board. He further stated that it was refreshing for him to witness their campaign free of personal attacks on anyone.

Mr. Camera read that he was disappointed to see the CNTEA endorse candidates and that those candidates that received the endorsement as well as the CNTEA touted this as "remarkable" because it had never been done before. He read that it is his belief that it was never done before for good reason and hopefully it will never be done again.

Mr. Camera continued reading, noting that as of January 1, 2024 six (6) of the nine (9) members of the board will have been elected under the banner of Colts Kids First ("CKF"). All six of the CKF candidates for office participated in what they had thought was a fair and unbiased 'Meet the Candidates Night' hosted by the CNTEA. The CNTEA then decided to endorse candidates in a small town in an attempt to influence the outcome of the election. Whether the endorsed candidates had won, or lost, the election is irrelevant. Mr. Camera noted that in either case, the CNTEA has damaged any opportunity to continue to have the type of relationship they should have with the Board of Education, which has direct influence over the terms and conditions of their employment.

Mr. Camera concluded his statement by reading that he is hopeful at some point there is an Executive Board of the CNTEA who recognizes the error of the current Executive Board and corrects this grave mistake going forward.

President Tormey then responded to Mr. Camera's statement, remarking that his comments sounded like a threat. Other members of the Board commented as well, and there was discussion amongst Mr. Camera and Board members regarding their opinions on the subject of his comments.
