Public Participation

The Board of Education recognizes the value of public comment on educational issues and the importance of allowing members of the public to express themselves on school matters of community interest. Public participation is governed under District Policy 0167 - Public Participation in Board Meetings as follows:

Public participation shall be governed by the following rules:

- 1. A participant must be recognized by the presiding officer and must preface comments by an announcement of his/her name, municipality of residence, and group affiliation, if applicable;
- 2. Each statement made by a participant shall be limited to three minutes' duration;
- 3. No participant may speak more than once on the same topic until all others who wish to speak on that topic have been heard; and only then if time constraints and/or the presiding officer allow.
- 4. All statements, questions, or inquiries shall be directed to the presiding officer; and any questions or inquiries directed by a participant to another Board member or Superintendent shall be redirected to the presiding officer who shall determine if such statement, question, or inquiry shall be addressed by the presiding officer on behalf of the Board or by the individual Board member or Superintendent;
- 5. It is the expectation of the Board that communications between participants and the Board will remain positive and focused around the best interest of the student(s) and the district as a whole. All communications from all stakeholders shall be conducted with mutual respect and civility. The Board will not condone communications and interactions that can be perceived as harassing, insulting, threatening, or lacking in respect or civility.

The presiding officer may:

- a. Interrupt, warn, and/or terminate a participant's statement, question, or inquiry when it is too lengthy;
- b. Interrupt and/or warn a participant when the statement, question, or inquiry is abusive, obscene, or may be defamatory;
- c. Request any person to leave the meeting when that person does not observe reasonable decorum;
- d. Request the assistance of law enforcement officers in the removal of a disorderly person when that person prevents or disrupts a meeting with an act that obstructs or interferes with a meeting;
- e. Call for a recess or an adjournment to another time when the lack of public decorum interferes with the orderly conduct of the meeting; and
- f. Waive these rules when necessary for the protection of privacy or to maintain an orderly operation of the Board meeting.

Kevin O'Connor made a brief statement, pointing out that the Tentative budget process is guided by the Vision and Mission Statements and the Strategic Plan. This is a Tentative budget, the final budget will be voted on in May and Dr. Gariaby will be doing a full presentation at that time. The Committee strives to make this Tentative budget as close as final as possible, but there can be changes for many reasons, some of which by the district, others driven by the County and/or the State. He commented that the Board's role is not to review the budget line by line, the Finance Committee has spent many hours reviewing all parts of this budget. The Board is tasked to vote in terms of "Abstain", "Yes" or "No" on the recommendations being put forth by the Committee. If you have an individual item that you wish to have the Committee review after today and before our final vote, please send an email and the Committee with review and provide feedback. Mr. O'Connor briefly reviewed the

process of how the Committee works to get to this Tentative budget. He further commented that he is proud of the work that has been done to reach this Tentative Budget.

Mr. Camera noted that he would be splitting his vote, voting "no" on Items 1, 2 and 6 because he feels they are spending resolutions that are not in favor of the amount that is in the budget. He announced he will be voting "yes" on Items 3, 4, and 5 as he believes they are conservative items that can help reduce the tax impact of the budget.

Requires Board members to receive approval of these expenses by a majority of the full voting membership of the Board and staff members to receive prior approval of these expenses by the Superintendent of Schools and a majority of the full voting membership of the Board; and

WHEREAS, a Board of Education may establish, for regular district business travel as defined in N.J.A.C. 6A:23A-1.2, which includes attendance at regularly scheduled in-State county meetings, Department or Association sponsored events or in-State professional development activities for which the registration fee does not exceed \$150.00 per employee or board member, where prior Board approval shall not be required unless the annual threshold for a staff member exceeds \$1,500 in a given school year (July 1 through June 30); and

WHEREAS, the Colts Neck Township Board of Education has established \$57,313 as the maximum travel amount for the current school year and has expended \$18,557 as of this date;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Education approves travel and related expense reimbursements in accordance with N.J.A.C. 6A:23A-7.3, to a maximum expenditure of \$48,430 for all staff and board members for the 2023-24 school year.
