



Rothman Orthopaedics (Reconstructive Orthopaedic Associates II, LLC), located at 833 Chestnut Street, 12th Floor, Philadelphia, PA 19107, is pleased to provide Sports Medicine physician coverage for the Penn-Delco School District (“District”) located at 2821 Concord Rd, Aston, PA 19014 during the 2025-2026 School Year. This document outlines the services that Rothman will provide and what the School District will provide in return.

Rothman Orthopaedics will provide the following during the August 1, 2025 through July 31, 2026 term:

1. As Sports Medicine Care Providers, RO will provide coverage for home football games for the High School(s) for the District. District shall retain a separate District Physician for all other District needs.
2. VIP Appointment Access to our Sports Medicine Physicians for acute sports medicine injuries. VIP Appointment access is available through our VIP Appointment Request app or by calling the VIP phone line.
3. Immediate access in our Rothman Orthopaedic Urgent Care Centers in Marlton, NJ, and Hamilton, NJ, and our Orthopaedic Walk-in Centers in Limerick, PA, Newtown, PA, Willow Grove, PA, King of Prussia, PA, and Glen Mills, PA during regular business hours
4. Direct access to Rothman Orthopaedics Concussion Program.
5. Rothman Orthopaedics shall provide proof of appropriate liability insurance coverage naming District as an additional insured under the policy. In addition, Rothman agrees to indemnify and otherwise hold the District harmless for any acts of negligence relative to their employees providing services under the terms of the herein agreement.

Compensation

In consideration for the Services provided by Physician pursuant to this Agreement, District agrees to compensate Physician for the period of August 1, 2025 through July 31, 2026, Two Hundred Dollars (\$200) for each home Football Game where coverage is provided by Physician. Rothman shall invoice District at the end of the football season. All invoices shall be paid within thirty (30) days of receipt.

The District will provide the following to Rothman during the August 1, 2025 through July 31, 2026 term:

1. Designation as “Official Orthopaedic Partner” of the District for marketing purposes. Other orthopaedic practices may serve as donors for the District or related entities but no other practice will be recognized as the Official Orthopaedic Partner.
2. (2) Banners to be produced and hung by school, subject to the school’s prior review and

approval, on athletic fields/gymnasiums (design provided by Rothman)

3. PA announcements at home games for the school year when an announcer is present
4. (3) sponsor acknowledgement messages per season (Fall, Winter, Spring) on the school's social media platforms (Facebook, Instagram, and/or X/Twitter)
5. (1) full page ad in the school's athletics publication, if applicable
6. Placement of the Rothman logo and link on the school's athletics website
7. Opportunity to have a table presence to promote Rothman and distribute marketing collateral at Home Football Games and other mutually-agreed to events.
