Request for Approval of Animal on District Property

Hold Harmless Agreement

I understand that according to Washington State law (RCW 16.08.040), "The owner of any dog which shall bite any person while such person is in or on a public place or lawfully in or on a private place including the property of the owner of such dog, shall be liable for such damages as may be suffered by the person bitten, regardless of the former viciousness of such dog or the owner's knowledge of such viciousness." Because I have care, custody and control of the dog, I am assuming the responsibilities of a dog owner.

I understand that I am strictly liable personally for the damage inflicted on any persons injured or harmed by the dog physically or emotionally in any manner. I shall provide proof of homeowner's insurance with a liability limit of at least \$1,000,000 per occurrence and \$2,000,000 aggregate to back up my claim of financial responsibility.

I shall indemnify, defend, protect and hold the Sumner-Bonney Lake School District, its officers, officials, employees and volunteers harmless from any and all claims, injuries, damages, causes of action, costs (including attorney fees), suits or judgments arising out of the injuries and damages in connection with bringing a dog in and outside of district property.

I shall provide proof that the dog is properly licensed, has received a health check, and is current on vaccinations. I shall also make sure that the dog has received regular flea treatment, and is groomed and bathed frequently. I shall also make sure that the animal is groomed and bathed frequently. I agree that the district is not responsible for the health, safety or care of the dog and I will clean up and dispose of my dog's waste properly on school property.
