## Millburn Community Consolidated School District 24 Yearly iPad Accident Protection Plan

Millburn School District 24 is providing and administering an accident protection plan for students and parents as part of our iPad Learning Initiative. Enrollment in this plan is required for **ALL** students (even if the iPad is not taken home). This plan covers "accidental damage" to the device and is designed to limit a family's financial responsibility for any damage as described in the coverage section below. In addition, each device is covered under a manufacturer's warranty that covers the normal operation of the device to ensure that it is functioning properly. *\*This fee is not eligible for coverage under the fee waiver program.*

<p style="text-align: center;"><b>Coverage</b> (Subject to Deductible Plan Below)</p> <ul style="list-style-type: none"> <li>● <b>Accidental Damage:</b> Pays for accidental damage caused by liquid spills, drops, or any other unintentional event.</li> <li>● <b>Theft:</b> Pays for loss or damage of the iPad due to theft. The claim requires a police report to be filed.</li> <li>● <b>Fire:</b> Pays for loss or damage of the iPad due to fire. The claim must be accompanied by an official fire report from the investigating authority.</li> <li>● <b>Electrical Surge:</b> Pays for damage to the iPad due to an electrical surge.</li> <li>● <b>Natural Disasters:</b> Pays for the loss or damage of the iPad caused by natural disasters.</li> </ul>	<p style="text-align: center;"><b>Exclusions</b></p> <ul style="list-style-type: none"> <li>● <b>Dishonest, Fraudulent, Intentional, Neglect or Criminal Acts:</b> Will not pay if damage or loss occurs in conjunction with dishonest, fraudulent, intentional, negligent or criminal act. The student/parent will be responsible for the full amount of the repair/replacement.</li> <li>● <b>Consumables:</b> Parent will pay 50% of consumables including but not limited to the case (\$60-\$100), the charger (\$29), and software.</li> <li>● <b>Cosmetic Damage:</b> that does not affect the functionality of the device. This includes but is not limited to scratches, dents, and broken plastic ports/parts or port covers.</li> <li>● <b>"Jail-breaking"</b> or otherwise voiding the manufacturer's warranty by altering the software.</li> <li>● <b>Millburn D24</b> is not liable for any loss, damage (including incidental, consequential, or punitive damages) or expense caused directly or indirectly by the equipment.</li> </ul>

<b>Annual Deductible Per Claim</b>			If a student loses an iPad more than once, take home privileges will be revoked
Deductible per Occurrence <i>(Per Student)</i>	\$50	Damage/Repair or Lost/Stolen	

If a student is unenrolled from Millburn District 24 for any reason, this accidental protection plan agreement becomes null and void on that date. There are no refunds once this agreement becomes active on the date the iPad is issued. The iPad must be returned on the last day of student attendance.
