2. REVISIONS OR CLARIFICATIONS ON QUESTIONS AFTER PRE-BID

- a. Q-001: On Monday the word "design" and or "designs was mentioned several times with regards to the RFP response. Is Orange County looking for the A/E Teams to provide a conceptual design (including site plan, floor plans, 3D visuals, etc) for the facility as part of the submission or were you referring to previous design examples / projects that the A/E team has completed.
 - Yes, we are looking for your conceptual design for the facility and if your firm is chosen to interview by our panel we will be asking and looking for previous projects your firm has completed.
- b. Q-002: Under Submittal Instructions, item 'F' notes that Offerors are not to submit estimated man-hours or cost for services with their proposals. Can you confirm that the County is not looking for a fee proposal for the A/E response, or is the A/E team to submit a fee proposal with the overall submission. There seemed to be some discrepancies between our in perserson discussion and the RFP Language.
 - Orange County Public Schools is looking for a total fee proposal for the entire project to be submitted with the overall submission and not an hourly rate for design.
