The Process

- x **October 9, 2024** - SEAB met to establish goals for the year and received training from the WISD on SEAB best practices and Michigan Law.
- x **November 11th, 2024** - SEAB determines curriculum auditing tool(s) based on community feedback and SEAB philosophy, goals and objectives.
- x **January 15th, 2025** - SEAB shares feedback on current curriculum using auditing tools. After revealing several gaps, it was decided to look at a new, comprehensive curriculum.
- x **February 20th, 2025** - Presentations from WISD on three different curriculums. The board decided to move forward with 3R Michigan Version and Michigan Model for Health.
- x **February-March:** Teachers and SEAB members reviewed the 3R Michigan Version and Michigan Model Curriculum.
- x **March 17th, 2025** -SEAB reviewed teacher recommendations and discussed individual lessons.
- x **April 23rd, 2025** -Individual lesson discussions continued.
- x **May 14th, 2025** -SEAB voted

- x Families notified 2 weeks prior to reproductive health lessons with guidelines for preview & opting out
- x Full materials available upon request
- x Families may opt out of individual lessons or entire unit
- x A summary email will be sent to families following the lesson.
