Repeated late pick ups will result in a termination of child care.

SITE INFORMATION

CONTRACT CHANGES/WITHDRAWALS

If you need to change your schedule or withdraw from the program, a schedule change / withdrawal must be submitted online. Contract changes will be made according to the following deadlines:

- Changes submitted by the 15th of the month will be effective on the 1st, or later, of the next month.
- Changes submitted by the last day of the month will be effective on the 15th, or later, of the next month.
- Verbal or email notification is not sufficient; changes must be submitted online. A \$10.00 fee will be charged to your account for each contract change. There is no charge when you withdraw.

PAYMENT OPTIONS

You may pay your tuition online by credit card (Visa, Mastercard, Discover, Amex) or by checking/savings account. You may also set up your account to make automatic payments each month by enrolling in AutoPay online in your account. Payments by cash, check, or money order are accepted on site.

DROP OFF AND PICK UP

- Please park in the lower south parking lot to drop off and enter through door #20, this is different than past years. Please pick up your child(ren) this summer at the same location (Door #20).
- During peak drop-off and pick-up times, there will be a greeter. If you need to drop off or pick up your child and there is not a greeter, call the site cell phone (651-967-2058).
- Parents must sign in and out on the iPad at the parent table. Please remember to also check your parent folder at this time.
- Please alert anyone picking up your child that they will be asked for **photo identification** when they come to pick up a child. **Only individuals listed on your child's authorized pick-up list will be allowed to pick them up.** If someone not on the list will be picking up your child, please inform the Site Coordinator.

FAMILY COMMUNICATION

Friendship Connection will send out weekly email reminders for upcoming field trips, daily specials, and activities. Emails will be sent to the address provided at registration. If you would like another person to receive emails, please talk to the Site Coordinator. Programming updates will also be posted in the parent area at your site.

AIR CONDITIONING

Friendship Connection cannot guarantee that all rooms will be air conditioned during the summer. We make every effort to utilize air conditioned spaces in buildings where it is available.

XCEL ENERGY SHUT DOWN DAYS

Roseville Area Schools participates in an energy saving program with Xcel Energy. At times during the summer, we may receive notification that we need to drop energy use at each building. Cutting energy usage means shutting off air conditioning, lights, computers, and other power sources for the rest of the day. We try and make these days extra fun through alternative programming; thank you for understanding that some programming may change at the last minute. If your child has special needs that may be affected by these shut downs, please inform the Site Coordinator.

WATER BOTTLES

Bring a water bottle every day to stay hydrated in the summer heat. Please label water bottles with names.

PROPER ATTIRE

Each day at Friendship Connection includes a variety of different types of activities. Please dress your child in comfortable clothes and shoes. Tennis shoes are recommended.

ITEMS FROM HOME

We ask that your child does not bring any toys or items from home. Friendship Connection is not responsible for any lost or damaged items brought to programming.

MEDICATIONS

MEDICATION POLICY

If your child needs to take medication anytime during the summer, a medication authorization form must be completed and signed. Medication must be provided in the pharmacy labeled bottle.

If your child will be taking the medication for longer than 2 weeks, we must have a signed note from the doctor and guardian.

Please be sure to talk to the Site Coordinator regarding any special medical needs or allergies.

SUNSCREEN

SUNSCREEN POLICY

By the nature of our program, students spend a great deal of time outdoors. Please review the following sunscreen guidelines.

At the time of registration, all families made a choice regarding sunscreen use; many chose to use Friendship Connection provided sunscreen. If you chose to provide your own sunscreen, please bring it on the first day of summer. We prefer that you provide a bottle that is left on site with staff to avoid not having sunscreen at Friendship Connection. If you did not authorize your child to apply sunscreen while at Friendship Connection, they will not be allowed to use Friendship Connection provided sunscreen or borrow from another student.

It is the responsibility of the parent/guardian to make sure your child understands proper sunscreen application. Friendship Connection staff cannot apply sunscreen for children. We can assist children by reminding them where to apply and making sure it is rubbed in. The responsibilities of Friendship Connection staff versus parents/guardians are outlined below.

Parent/Guardian Will:

- 1) Apply sunscreen prior to arriving at Friendship Connection each day.
- 2) If applicable, provide a clearly labeled bottle of sunscreen for your child to keep at Friendship Connection.
- 3) Review sunscreen application procedures with your child so they can responsibly apply sunscreen throughout the day.

Friendship Connection Will:

- 1) Ensure children apply sunscreen 30 minutes prior to extended outside time, recess, and choices.
- 2) Encourage children to wear t-shirts and hats while outdoors.
- 3) Remind students to reapply sunscreen throughout the day.

DAILY PROGRAMMING

SUMMER THEME: LEVELING-UP

Welcome to a summer experience like no other, a world where education meets adventure, and students become heroes in their learning journey. "Quest for Knowledge" transforms the classroom into an interactive gaming world where each student is a Player on a mission to develop skills, gain wisdom, and conquer academic challenges.

Upon entering this immersive world, students create a unique character or avatar, their in-game persona. They'll choose a name, design a symbol or crest, and set personal learning goals (like character stats). These avatars will "level up" as students earn XP (Experience Points) through daily tasks, team quests, and skill-building challenges.

Every day, students will encounter new Side Quests (daily learning activities such as puzzles, reading challenges, or creative prompts) that help them build core skills in fun ways. At the same time, they'll work on larger Main Quests, weekly cross-disciplinary projects that require creativity, collaboration, and critical thinking.

CHOICE TIME

During this time, the following activities may be offered. The activities that we provide are staff and student-driven.

- Camps: A variety of themed opportunities that run throughout the summer. Camps are limited to 15 students. Students may be able to sign up in advance of when the camp starts.
- Dramatic Play/Art: Pre-planned art activities with the option to participate in imaginative play with costumes and toys.
- Arcade: Activities that involve learning and exploring technology such as playing pre-approved games on the Nintendo Switch, iPad, or Friendship Connection website.
- Gym/Outside: Staff-led competitive and cooperative games as well as free time.

MOVE AND GROOVE

During Move and Groove time, students will choose between daily activity options. Choices range from going on walks, to aerobics, to soccer. The goal is to get kids moving while having fun.

STEM (Science, Technology, Engineering and Math)

Students will explore these concepts through a variety of age appropriate games and activities.

Science activities may include projects that introduce chemistry, biology, ecology, physics, and astronomy. STEM activities give students opportunities to solve problems, think critically, and work in small groups.

TEAM TIME

Team building, communication, and cooperation are the focus of team time. These skills are practiced and improved through a variety of activities.

STAR (Summer's Totally Awesome Readers)

Each day students spend time participating in intentional reading or language arts activities. Our goal is to make reading enjoyable for everyone; literacy time may include partner reading, reading out loud, word games, and writing.

DAILY SPECIALS

Daily specials are fun activities that add variety and excitement to every day! Check the white board in the parent area for up-to-date times and information about daily specials. Daily special information is also included in monthly programming calendars in this handbook.

BREAKFAST AND LUNCH

Breakfast and lunch is provided during the summer through a partnership with nutrition services. Please see the nutrition services website for the menu. If your child does not want a school lunch, a lunch from home is required.

SNACK

Friendship Connection will provide an afternoon snack for all participants.

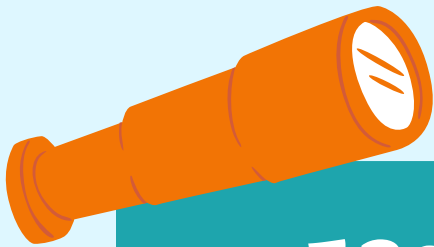

Parkview Summer Friendship Connection Swimming Field Trips 2025

All students attending a Friendship Connection swimming field trip must have a designated swim level otherwise, they will be designated RED, a shallow water only swimmer. Outlined below are the swimming field trip locations your site will be attending. We require all families to return this permission slip, even if you are choosing not to send your child on the trips. If we do not receive a permission slip for your child, they will not be allowed to attend the swimming field trip.

If you want to sign your child up for a trip on a day they do not normally attend, you must sign up for additional care at your site. Signing this permission slip does not sign you up for care. If you did not select a trip but wish to add it later, it will be subject to space availability.

Please identify what swim level you want for your child for each location. Levels may vary by trip. RED, YELLOW or GREEN:

Cascade Bay

Cascade Bay has a zero-depth entry pool, 2 regular slides, a lazy river (3 ft depth) with a raft slide, 2 drop slides, and a deep end.

- ☐ I do not want my child to attend this trip
- ☐ Red: Zero depth entry 0 to waist deep
- ☐ Yellow: Lazy River with raft slide to 3 feet, 2 regular slides into 2-3 feet of water.
- ☐ Green: 2 drop slides and a deep end approximately 4-6 feet deep.

Shoreview Community Center (Tropics Waterpark)

Tropics consists of a zero-depth pool, a lily pad water walk, 4 4-foot play pool, and a 3-story water slide.

- ☐ Red: Zero-depth interactive water play area 0-24 inches deep
- ☐ Yellow: Water slide into 3 feet 6 inches and lily pad water walk into 3 feet 6 inches of water
- ☐ Green: Maximum depth 4 feet 6 inches

Valleyfair

Valleyfair has 3 water slides, 2 raft slides, and a lazy river. (Children will not be allowed to access the wave pool)

- ☐ I do not want my child to go to the water park on this trip
- ☐ I want my child to go to the water park on this trip, and understand that by agreeing to this, my child will have access to all swimming areas except the wave pool.

Parkview Pool

Parkview Pool, where students can have a free swim opportunity. The Parkview Pool is 3-5 feet deep. Students will not be allowed to use the diving well.

- ☐ I do not want my child to participate in pool days.
- ☐ I want my child to go to the pool and understand that by agreeing to this, my child will have access to all swimming areas.

Parent/Guardian Authorization

1. I certify that I am the parent/guardian with legal responsibility for the child identified on this form.
2. I authorize my child to be transported in an authorized vehicle, either a school bus or a district van.
3. To the best of my knowledge, I certify that there is no medical reason why my child cannot safely participate in the field trip(s).
4. If my child needs immediate medical attention while participating in the field trip(s) or traveling to or from the field trip(s), I authorize first aid and transportation to a healthcare facility for emergency services as needed.

Release of Liability

By signing this form, I request that my child participate in the field trip(s) as indicated. I understand my child's participation in the field trip(s) is voluntary. I further acknowledge that the field trip(s) involved known and unanticipated risks which could result in injury or death to my child, and I elect to have my child participate in the field trip(s) despite such risks. I also voluntarily assume and accept the possible injury, death, damage, or loss that my child may suffer due to negligence or accident while traveling to or from, engaged in, or otherwise participating in the field trip(s).

In consideration for the opportunity to participate in the field trip(s) I, on behalf of myself, my agents, heirs and next of kin, hereby agree to release, indemnify and hold harmless Independent School District No. 623, its employees, agents, officers, representatives, volunteers, participants, School Board members, and all other persons or entities acting on behalf of Independent School District No. 623 from any and all claims, demands, or causes of action which are in any way connected with my child's participation in the field trip(s) arising from negligence or due to accidental occurrences. This Release does not apply to claims arising from intentional conduct.

RELEASE OF LIABILITY. ASSUMPTION OF RISK. INDEMNIFICATION AND WAIVER AGREEMENT

I, (PARTICIPANT or PARENT), on behalf of myself or my minor child, my heirs, executors, administrators and assigns, release, waive, discharge and covenant not to sue Zero Gravity Trampoline Park, LLC ("Zero Gravity"), its owner, officers, governors, contractors, agents and employees and agree to hold it harmless from all liability for its negligent acts or omissions resulting from any participation in trampoline court activities, laser tag, net course, and other amusement activities, known or unanticipated, that result in physical or emotional injury, paralysis, death or damage to myself, to my minor child, or to our property.

I acknowledge on behalf of myself or my minor child that the activities and services offered by Zero Gravity are inherently dangerous and may cause injury or damage. I am assuming on behalf of myself or my minor child all risk of personal injury, death or disability which may result from participation or use of Zero Gravity's facilities or activities. This Release, Assumption of Risk, Indemnification, and Waiver specifically extends to the use of trampolines, laser tag, net course, and other equipment and the premises of Zero Gravity and includes any claim for strict liability arising out of the use of such trampolines, laser tag, net course, or equipment. I certify that I have adequate health insurance to cover any injury or damage cause to me or my minor children, or else I agree to personally bear the cost of such injury or damage.

I agree that this Agreement extends forever into the future and covers any visit for which this Release, Assumption of Risk, Indemnification, and Waiver applies as well as any return or repeat visits by either myself or my minor child in the future. I agree to defend, indemnify and hold Zero Gravity harmless from any and all losses, liabilities, claims, damages or other financial harm incurred by Zero Gravity, including reasonable attorneys' fees, as a result of any action of myself or my minor child as well as any injury or damage cause to any other person during my participation and activities at Zero Gravity.

I hereby authorize and consent to the use of my voice, photograph and likeness as well as that of any minor child covered by this Agreement by Zero Gravity without reservation or limitation. I agree to receive no compensation for this use, and property rights to any photographs or video material produced or prepared by Zero Gravity shall vest in and remain with Zero Gravity. The waiver and release included in this Agreement shall extend to the use of voice, photograph or likeness covered by this paragraph.

I UNDERSTAND THAT BY EXECUTING THIS AGREEMENT I AM GIVING UP ANY RIGHT TO BRING LEGAL ACTION OR ASSERT A CLAIM AGAINST ZERO GRAVITY FOR ITS NEGLIGENCE OR FOR ANY DEFECTIVE PRODUCT ON ITS PREMISES. PARTICIPANT AGREEMENT, INDEMNIFICATION, RELEASE AND WAIVER OF LIABILITY AND ASSUMPTION OF RISK

PLEASE READ THIS DOCUMENT CAREFULLY. BY SIGNING THIS DOCUMENT YOU ARE GIVING UP YOUR AND YOUR MINOR CHILD'S LEGAL RIGHTS.

I understand that trampolining and/or participating in any activities in, on, around, in connection with or associated with trampolines or any other activities (hereinafter, the "Activities") on the premises operated by Scando Entertainment LLC and/or Epic Air Trampoline Park and/or any of their owners, officers, directors, managers, employees, representatives, agents, parents, subsidiaries, and other affiliates (collectively, "Epic Air") are inherently dangerous Activities, involving known and unknown risks of physical and/or mental injury, including but not limited to permanent physical and/or mental injury and even death.

In consideration of Epic Air permitting me and/or the child for whom I am a parent or legal guardian (my "Child") to participate in any such Activities on the premises operated by Epic Air, I, on behalf of myself, and on behalf of my Child, and further including my heirs, agents, assigns, family members, spouse, domestic partner, parents, children, estate, and any other persons acting or purporting to act on my or my Child's behalf, do hereby expressly and voluntarily release, remise, discharge, defend and agree to fully indemnify Epic Air and its direct and indirect owners, officers, directors, managers, employees, representatives, agents, parents, subsidiaries, and other affiliates from any and all liability that may arise, as more specifically described as follows:

RELEASE OF LIABILITY: I hereby release, remise, acquit, discharge, covenant not to sue, agree to defend, indemnify, and hold harmless Epic Air, from any and all liability, claims, demands, actions or causes of action, damages, suits, debts, sums of money, accounts, reckonings, bonds, bills, trespasses, damages, judgments, executions, claims and demands whatsoever in law or in equity, for, upon or by reason of any matter, cause or thing whatsoever, including but not limited to any physical or mental injuries or death suffered by me or my Child, incidental to, arising out of, or connected with my or my Child's participation in the Activities, including such injuries or death caused by or as a result of Epic Air's negligence.

ASSUMPTION OF RISK: I acknowledge that I and/or my Child am/is freely and voluntarily participating in the Activities, which inherently entail both known and unknown risks, and that: (a) such participation may lead to physical injury, mental injury, and/or death, including but not limited to, heart attacks musculoskeletal injury, cardio-respiratory injury, muscle strains, muscle pulls or tears, broken bones, cuts, bruises, scrapes, concussion, head injuries, spinal injuries, heat exhaustion or heatstroke, fainting, knee/back/foot injuries, eye injuries, illness, soreness, rash, and other diseases, injuries, and/or detriments to my or my Child's physical condition; and (b) that such injuries or death may result from, including but not limited to, the Activities and/or exposed springs, hooks, frames and/or other equipment, poor lighting, lack of supervision or training, lack of instruction, lack of protective padding, mats, netting, and/or other safety equipment, slipping or falling on or off equipment, collision with fixed objects or other persons, jumping, running, tumbling, somersaults, acrobatic maneuvers or stunts, multiple participants simultaneously participating in the Activities, the physical condition, fitness, and/or abilities of participants, weather and environmental conditions, actions, omissions, recklessness, negligence on the part of Epic Air or its Employees, myself, and/or, my Child, and any other lack of safety measures. I hereby expressly assume the risk of any such physical or mental injuries, death, medical expenses, or other loss that I or my Child might sustain as the result of participating in any Activities. By visiting Epic Air, I voluntarily assume all risks related to any viral or biological disease exposure from touching any surface touched by other guests or staff or by being in the vicinity of other guests or staff that may be ill, with or without visible symptoms. I further state that I have explained the aforementioned risks to my Child. I certify that I have adequate health insurance to cover any injury I or my Child may suffer as a result of participation in the Activities or that I agree to be personally and solely responsible for all medical costs and expenses arising from any such injury.

PHOTO RELEASE: On behalf of myself and my Child, I hereby grant Epic Air, an irrevocable, royalty free, perpetual and worldwide right to photograph and video and/or audio record me and my Child in connection with any Activities and to use such photographs and/or recordings and any derivatives thereof for any purpose whatsoever in any and all media now known or hereafter devised, including but not limited to advertising and promotion. I agree that I am granting Epic Air the rights herein without being entitled to or seeking any compensation whatsoever therefor. I agree that all photographs and recordings are the exclusive property of Epic Air and waive any right to approve to or object Epic Air's use of any such photograph or recording.

As stated in greater detail above, I agree that if the participate Child is a minor, as determined by Illinois state law, this Release of Liability and Assumption of Risk Agreement is made on behalf of that Minor participant and the releases, waivers and promises herein are binding on the Minor participant and that I have full authority as parent or legal guardian to bind the Minor participant to this Agreement without limitation.
