

HISTORY OF THE BOARD OF EDUCATION

The following is a summation of events taken from actual Minutes of the Board of Education:

On June 16, 1884, Col. Martin, R. D. Coughanour, and E. M. Tillman assembled in the office of R. D. Coughanour and organized the Board of School Trustees. Col. Martin was elected President and E. M. Tillman was elected Secretary of the Board.

The Dallas City Council approved "An Ordinance To Provide For Conducting and Managing the Free Public Schools of the City of Dallas" on July 21, 1884 which stipulated that one "Director" would be elected from each "Ward," beginning at the general city election in April, 1885. The "Directors" elected at that time would draw lots "to serve one and two years respectively so that half thereof shall be annually thereafter elected to serve for two years. The four Trustees already appointed and organized for the present year shall continue as the Board of Directors herein provided for."

On July 25, 1884, the newly appointed Directors -- G. M. Swink of 5th Ward and J. H. Jones of 3rd Ward -- appeared and participated in the transactions of the business of the Board.

At the August 1, 1884 meeting, "Applications of prospective Superintendents were opened and read . . . a vote taken, and Professor W. A. Boles, having received four, a majority of the votes, was declared duly elected Superintendent of Schools."

Following the April, 1885 election, the first meeting of School Trustees elected according to provisions of the City Ordinance held their first meeting on June 22, 1885.

"It was moved and carried that lots be cast to determine who should act respectively for the long and short terms of two and one year respectively, with the following results:

Long term of two years - John H. Jones, W. F. Ewing and Paul F. Erb.

Short term of one year - R. D. Coughanour, C. A. Gill and E. P. Marshall.

Election of officers for one year resulted as follows: W. F. Ewing, Pres., R. D. Coughanour, Vice President, and John H. Jones, Secretary.

Professor R. Stanberry was elected unanimously as Superintendent of Schools."
