TURF FIELDS & TRACK USAGE RULES AND REGULATIONS:

NO METAL CLEATS ALLOWED:

- Participants are only to use molded rubber or plastic bottom cleats or sneakers. A cleat check must be performed prior to entering the fields. NO METAL CLEATS

WATER ONLY

- Water is the only liquid drink to be used on the turn and track. NO JUICES or COLORED LIQUIDS

NO GLASS BOTTLES OR CONTAINERS

- Only plastic water bottles and containers are allowed.

NO FOOD, SUNFLOWER SEEDS, GUM

NO PETS ALLOWED ON SCHOOL PROPERTY

NO SHARP OBJECTS

- No Stakes, Tents or anything that will go into the turf or track surface.

NO BIKES, SKATEBOARDS, ETC

NO GARBAGE LEFT- Please clean up after your event.
