By the execution of this Waiver and Release, I accept and assume full responsibility for any and all injuries, damages (both economic and non-economic), and losses of any type, which may occur to me, and I hereby fully and forever release and discharge the School, its insurers, employees, officers, directors, and associates, from any and all claims, costs (including attorney fees), demands, damages, rights of action, or causes of action, present or future, whether the same be known or unknown, anticipated, or unanticipated,

I expressly agree to indemnify and hold the School harmless against any and all claims, demands, damages, rights of action, or causes of action, of any person or entity, that may arise from injuries or damages sustained by me resulting from or arising out the use of the Health and Wellness Center or entry upon the Germantown Academy campus.

I agree to be solely responsible for my safety and wellbeing. I understand that the School is not obligated to provide supervision, instruction, or assistance for the use of the Health and Wellness Center.

I understand that the School makes no representation as to the condition of the Equipment, and I am using the Equipment "as is" of my own choice and at my own risk. Accordingly, I assume all risks, injury, medical condition, emergency or illness to me that may occur during participation in any activities or use of the Health and Wellness Center.

I understand that the School is not requiring, requesting or suggesting that I use the Health and Wellness Center and that it is being made available for voluntary, leisure time use.

I acknowledge that I am physically fit and mentally capable of performing the physical activity or physical activities I choose to participate in at the Health and Wellness Center.

I agree to comply with all rules imposed by the School regarding the use of the Wellness Center and agree to conduct myself in a controlled and reasonable manner at all times and to refrain from using the Equipment in a manner inconsistent with its intended design and purpose. I understand that it is my obligation to use the Health and Wellness Center in a safe and responsible manner and to keep the same clean and orderly. I further understand that my right to use the Health and Wellness Center may be revoked or modified by the School at any time.
