0120 AUTHORITY AND POWERS

Authority

The Paterson Board of Education recognizes the school district's status as a State Operated School District as of the adoption of this Policy. The Board will conduct its business in accordance with New Jersey Statutes and New Jersey Administrative Code adopted by the New Jersey Department of Education.

In accordance with the State Takeover Report to the State Board of Education prepared by the Commissioner of Education dated June 19, 2002, the Board acknowledges the Commissioner's intentions to return the Paterson School District to local control with new legislation that reflects criterion for return to local control.

Subject to the statutes and regulations affecting state takeover and return to local control, the Board shall make, amend, and repeal rules not inconsistent with statutes or with the rules of the State Board of Education for its own government and the transaction of its business and for the government and management of the public schools and the public property of the school district and for the employment, regulation of, conduct, and discharge of its employees. The Board shall perform all acts and do all things, consistent with law and the rules of the State Board, necessary for the proper conduct, equipment and maintenance of the public schools of the district.

The powers enumerated in the following policies, marked with an asterisk, shall continue to be within the powers of the State District Superintendent, until such powers are returned to local control by relevant statutes or regulations or the Commissioner of Education:
