### ESSA (Every Student Succeeds Act) Public Notice

#### Intent to Apply for the 2025-2026 ESSA Federal Grant Funding

**“In accordance with United States Code (U.S.C.) Annotated, Title 20, Chapter 70, Subchapter VIII, Part C, Section 7846, and Public law (P.L.) 114-95, Every Student Succeeds Act (ESSA), Section 8306, an entity planning to submit a federal grant application must afford a reasonable opportunity for public comment on the application before it is submitted.” Therefore, Santo Independent School District is making public notice of intent to apply for the 2025-2026 ESSA Consolidated Application for funding. Santo ISD will apply for the following program areas:**

**Title I, Part A, Improving Basic Programs** - Intent and Purpose: Title I Part A, provides supplemental resources to LEA's to help schools with high concentrations of students from low-income families, provide high-quality education that will enable all children to meet the challenging state academic standards.

Award Amount: \$98,575

Allowable Uses Include:

- Instructional supplies and materials
- Professional development for staff and parents/guardians
- Professional and contracted services
- Staff salaries (professional, certified and paraprofessional)

**Title II, Part A, Preparing, Training, and Recruiting High-Quality Teachers, Principals, or Other School Leaders** - Intent and Purpose: Title II, Part A, provides resources to LEAs for the following: to increase student achievement on state academic standards, to improve the quality and effectiveness of teachers, principals, and other school leaders, to increase the number of teachers, principals and other school leaders, to provide low-income and minority students greater access to educators

Award Amount: \$16,429

Allowable Uses Include:

- Redirect 100% of these funds for use on Title I, Part A campuses.
- Redirect 100% of these funds for Title IV, Part A purposes.
- Professional development supplies and materials
- Staff salaries (professional, certified and paraprofessional)
- Professional and contracted services
- Professional development for staff and parents/guardians

**Title IV, Part A, Student Support and Academic Enrichment** - Intent and Purpose: To improve the academic achievement of all students by increasing the capacity of LEAs, schools, and communities to provide all students with access to a well-rounded education, to improve school conditions for student learning, and to improve the use of technology in order to enhance academic outcomes and digital literacy of students

Award Amount: \$10,000

Allowable Uses:

- Redirect 100% of these funds for use on Title I, Part A campuses.
- Redirect 100% of these funds for Title II, Part A purposes.
- Instructional supplies and materials
- Professional development in technology and contracted services
- Technology infrastructure (limitation – 15%)
