Section	551.074	For the purposing of considering the appointment, employment, evaluation, reassignment, duties, discipline or dismissal of a public officer or employee,

		or to hear complaints or charges against a public officer or employee;
Section	551.076	For the purpose of deliberation regarding security devices or security audits;
Section	551.0821	For the purpose of deliberating a matter regarding a public school student if personally identifiable information about the student will necessarily be revealed by the deliberation;
Section	551.083	For the purpose of deliberating in consultation with a representative of an employee group;
Section	551.084	For the purpose of excluding any witness or witnesses from a hearing during the examination of another witness.

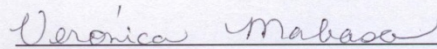
Should any final action, final decision or final vote be required in the opinion of the board with regard to any matter considered in such closed or executive session, then such final action, final decision or final vote shall be at either:
