1. <u>Approval of Minutes</u>

Patricia Lock Dawson tabled the minutes of the March 20, 2019, April 17, 2019, and May 22, 2019.

2. <u>Community Facilities District No. 37</u>

RUSD Financial Advisor and Bond Counsel presented information on the Community Facilities District (CFD) No. 37 formation process with the subcommittee.

The CFD No. 37 location is described as Wood Road and Lurin Avenue. The projected development is 90 single-family detached residential units and square footage ranging from 2,805–3,209. The developer is Coastal Commercial Properties.

The CFD No. 37 funding amount for RUSD Facilities is estimated at \$1,938,490. Western Municipal Water District improvements are estimated at \$1,937,490, and the City of Riverside improvements are estimated at \$350,218 for a total of \$4,226,198 overall estimate in funding.

After receiving information and timeline summary, subcommittee members recommended that the process to form the CFD No. 37, move forward for approval on the Resolution of Intention to Incur Bonded Indebtedness and the approval of the Mitigation Agreement and

Indebtedness in an amount not to exceed for CFD during the Board of Education meeting scheduled for October 1, 2019. During the November 12, 2019 Board of Education meeting, the Board of Trustees will consider the adoption of the Resolution of Formation for the CFD No. 37, the CFDs Mitigation Agreement, and the Joint Community Facilities Agreement.
