#### VI. RECREATION DEPARTMENT REPORT:

Dustin Huguenin reported that long-time Ellington High School boys' lacrosse coach, David Giordano is retiring at the end of this spring season after 23 years. The Giordano family will be having a dedication to honor his support and guidance to the program on June 1<sup>st</sup> at Pinney Fields, inviting former Alumni and current players. The community garden at the Batz property is ready for planting. Dek Hockey has two groups running a small 6-week pilot program. Rich Willis, EHS Tennis Coach and longtime recreation Tennis Coach has started a new youth Team Tennis program that is heavily attended. Spring Soccer and Lacrosse are going well; there has been an increased number of girls in both sports this spring. Sandy Beach will be opening Memorial Weekend (weather & staff permitting). Assistant Recreation Director/Waterfront Director, M. Bartley informed the commission that she has nine staff out of 14 from last summer and is recruiting more employees to make sure the waterfront will be managed in a safe and exciting. Recreation Supervisor, Kevin Barrett gave an update on the Summer Day Camps. Mr. Barrett stated that the Day Camp staff has a large number returning from last year (20+) and they have begun planning for the camps being held at the Crystal Lake School and for our Teen Adventure Camp held at EMS for one week this summer. Numbers are filling up for the eight weeks of camp.

There is some concern about the summer camps for next year as the State is currently trying to change camp requirements, which can be very costly for us to hold camps in the future.

Mr. Huguenin will keep the Commission appraised for updates. J. Boucher has asked Recreation Director Huguenin to provide him with some numbers and current feedback due to the new proposal of this Bill.
