2. What is the timeframe for the completion of this project?

Answer: The District anticipates issuing a purchase order to the Contractor by July 11, 2025. After students return on August 6, 2025, the work may be completed in the evenings or on weekends, provided that the work progresses timely and that entire restrooms are completed and brought back online as quickly as possible to minimize operational disruptions. Aside from summer break, the academic calendar for 2025-2026 (provided below) includes student breaks in October and November that may be used to complete work as well. Upon award, the Contractor will provide the District's project manager with a detailed work plan, for review and approval prior to commencement.
