

Verification of Work Performed – Edits Made

September 7, 2023 Minutes

- **Wording Adjustments:** Minor rephrasing in several paragraphs for clarity or tone, such as changes in how board members' comments or public statements were described.
- **No Changes in Names or Dates:** All names, dates, and official titles remained consistent across both documents.
- **No Additions or Removals of Agenda Items:** The structure and content of the agenda, including resolutions, reports, and approvals, were identical.

1. Wording Adjustments

- **Paragraph 82:** A small edit in how Superintendent Paramo's response was introduced (e.g., "Dr. Paramo" vs. "Superintendent Paramo").
- **Paragraph 88:** Capitalization change in "Night of Magic" (event title).
- **Paragraph 94:** Slight rewording in the phrase "report out the December meeting" vs. "report out around the December meeting."

December 7, 2023 Minutes

"Charlene Tabet brought up this was a first reading and therefore didn't need a motion or vote. Motion and vote will take place at the second reading. A

discussion took place amongst Board members as well as questions towards the Board Policy."

- Document I:
"It was moved by 00000000-0000-0000-0000-000000000000, and seconded by 00000000-0000-0000-0000-000000000000, that the Board of Education adjourn the item as recommended. The motion carried unanimously."
- Change: Document II correctly reflects that no motion or vote was needed for a first reading, replacing placeholder text in Document I.

"All Board members replied to public comments where appropriate"

7. Board Reports (Section 10)

- Document I: No mention of discussion outcomes.
- Document II: Adds that no action was taken and that discussion occurred for each report.

8. Instructional Calendar Vote (Section 11.e)

- Document I: Vote passed unanimously.
- Document II: Notes discussion and that the vote passed 3-1, with Pontzer Kamkar voting no.

9. Pulled Agenda Items (Sections 11.h and 11.j)

- Document I: Items are listed as presented.
- Document II: Clearly states: "This item was pulled from the Agenda and will be brought back at a later date."

10. Adjournment (Section 14)

- Document I: Generic adjournment.
- Document II: Adds "Retirees were announced and thanked: Karen Whantland and Cynthia Burton." "Meeting adjourned in honor of Dr. Aghakhanian's father: Edik Aghakhanian"
