

# Background

- May 2024 – School Board voted to authorize the plan for Bear Hill Elementary School (BHES), including development of a new enrollment areas map
- Because BHES will be the first new school built in the district in over 50 years, it is necessary to review enrollment and attendance boundaries across the district.



# Meeting Goals

- Review 2018 redistricting process
- Decide on high-level process for BHES redistricting
- Establish timeline



# 2018 Redistricting Process

- 3 schools involved – Beaumont, Devon, Hillside
- Work was carried out by a District steering committee (Elementary Redistricting Committee)
- Composition of Elementary Redistricting Committee:
  - Board Members
  - Administrative Staff
  - Parents
  - External Facilitator
  - Consultants as needed (Demographer, Transportation Supervisor, etc.)



# 2017-18 Redistricting Timeline

- Spring 2017 – Ad Hoc Enrollment committee developed plan to address enrollment imbalances through redistricting (included parameters, work plan)
- May 2017 – School Board authorized plan; solicitation of parent volunteers for redistricting steering committee
- June 2017 – First meeting(s) of redistricting steering committee
- Fall 2017 – Weekly meetings of redistricting steering committee to develop plan along with monthly community update meetings
- December 2017 – Redistricting plan presented to School Board
- January 2018 – School Board votes on redistricting plan
- Spring 2018 – Administration implements transition plan with schools and families
- August 2018 – New attendance boundaries take effect




# Proposed BHES Redistricting Process

- All elementary schools to be considered
- Work to be carried out by a similar District steering committee including board members, administrators, parents, and consultants as needed



# Proposed BHES Redistricting Timeline

- Summer 2025 – District administration gathers information for Ad Hoc Committee
- Fall 2025 – Ad Hoc committee develops parameters and work plan
- Spring 2026 – Selection of District steering committee members
- Summer & early Fall 2026 – District steering committee work
- Late Fall 2026/Winter 2027 – Presentation of plan & Board vote
- Winter/Spring 2027 – Implementation of transition activities



# Next Steps

- Report BHES redistricting process and timeline to Board
- In accordance with the proposed timeline, the Ad Hoc Redistricting Committee would hold meetings in Fall 2025 to
  - establish parameters for redistricting, considering legal requirements, best practices, costs and other factors
  - determine how the work should be performed, how the proposals will be developed, and the composition of the District steering committee
