### WHS Addition and Renovation Project ~ Schematic Design Meeting December 6, 2023


An informational meeting was held for the Westside Community Schools Board of Education on Wednesday, December 6, 2023, at 4:00 p.m. at the District Administration Office - ABC Building - 909 S. 76th Street, Omaha, Nebraska. This meeting was only for the purpose of sharing schematic design information for the addition and renovation project (Life Complex) at Westside High School. No official business was conducted.

Board members in attendance: Sarah Rider, Meagan Van Gelder, Dana Blakely

Notice of the meeting was given by placing advance notice on the District's website no less than 48 hours in advance of the scheduled commencement of the meeting as authorized by Board Policy 1220. Notice for this meeting appeared beginning on December 4, 2023, and appeared continuously up through the start of this board meeting. Notice of the meeting was also published in the Daily Record on December 5, 2023, and on their website. Notice of this meeting and the availability of the agenda was simultaneously given to all members of the Board of Education and available to anyone at the Board of Education office. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

Mr. Matt Herzog with Project Advocates confirmed that public notice had been given of the meeting under the Nebraska Open Meetings Act and that a copy of the Nebraska Open Meetings Act was posted at the meeting and on the district website, as required by law, and the agenda was available to any interested parties. Board member attendance is noted above.

Mr. Chris Houston with TACK Architects presented the Schematic Design for the Westside High School addition and renovation project - the "Life Complex". He reviewed key design goals identified by the Design Advisory Committee to further refine the design for the Life Complex. The next board approval item for this project will be at the Design Development phase, currently scheduled for January 2024.


