#### **Executive Summary**

The Riverside Unified School District (RUSD) was successful passing Measure O General Obligation Bond on November 8, 2016. With a 70% approval rate, the voters approved to issue up to \$392,000,000 as the principal amount for the District's school facilities bond (Measure O). Measure O will generate the dollars over the next 10 to 15 years to improve existing school facilities and build new capital facilities in Riverside Unified School District.

The Long Range Facility Master Plan completed in 2016 serves as the guide to plan projects based on condition, educational program, capacity needs, and available state funding. The Board of Education held three workshops to discuss the needs of district facilities and identify priorities. The workshops primarily focused on educating the Board and public on the prioritization process, providing data on the facilities, determining focus goals, and identifying priority projects.

#### 2016 Ballot Measure O

The following is the ballot measure summary presented to the voters by the Riverside Unified School District.

"To repair and upgrade Riverside schools, including deteriorating roofs, plumbing and electrical systems, improve student safety, security, and seismic safety, upgrade classrooms, science labs, career-training facilities, computer systems and instructional technology to support student achievement in math, science, engineering and skilled trades, and construct, acquire, repair classrooms, sites, facilities and equipment, shall Riverside Unified School District issue \$392 million in bonds at legal rates, with citizen oversight, no money for administrator salaries, all money staying local?"

#### Purpose of the Committee

Pursuant to Section 15278 of the Education Code, the District is obligated to establish an independent Citizens' Bond Oversight Committee (CBOC) in order to satisfy the accountability requirement of Prop. 39. The Board of Education approved the appointment of the CBOC at its March 20, 2017 Board meeting.

The purpose of the Citizens' Bond Oversight Committee (CBOC) shall be to inform the public concerning the expenditure of the bond proceeds. The CBOC will review bond program expenditures and outside audits to make sure the will of the voters is strictly followed in accordance with the wording of the original ballot measure.

To carry out its stated purpose, the Committee shall perform the duties set forth in the CBOC bylaws as listed below:

3.1 Inform the Public. The Committee shall inform the public concerning the District's expenditure of bond proceeds. In fulfilling this duty, all official communications to either the Board or the public shall come from the Chair acting on behalf of the Committee. The Chair shall only release information that reflects the majority view of the Committee.

- 3.2 Review Expenditures. The Committee shall review expenditure reports produced by the District to ensure that (a) bond proceeds were expended only for the purposes set forth in Measure O; and (b) no bond proceeds were used for teacher or administrative salaries or other operating expenses in compliance with Attorney General Opinion 04-110, issued on November 9, 2004.
- 3.3 Annual Report. The Committee shall present to the Board, in public session, an annual written report for Measure O, which shall include the following:
  - (a) A statement indicating whether the District is in compliance with the requirements of Article XIIIA, Section 1(b)(3) of the California Constitution; and
    - (b) A summary of the Committee's proceedings and activities for the preceding year.

#### Committee Membership

The Committee is composed entirely of District residents, including those with experience in business, government, finance and education, as well as parents of Riverside Unified School District children, a member of a taxpayer association, and member of senior citizens' community, and parent-teacher organizations.

One committee member was an employee of RUSD and voluntarily resigned from the committee.

#### **Committee Activities**

In accordance with the provisions of the Ralph M. Brown Public Act, the committee conducts meetings for the public's attendance and participation. Meeting agendas and notices are sent to committee members and posted 72 hours in advance of the meeting. Notices are posted at the Riverside Unified School District office, Business office, Facilities Planning and Development office and on the district website. Meeting notices, agenda, minutes and all other documents received by the committee are a matter of public record and are available on the Riverside Unified School District website:

At every meeting staff reports the status of projects and project financials.

At every meeting, the committee has encouraged and has received community input related to concerns with Measure O funding allocation. These concerns have and will continue to be discussed by the committee as brought forth in public comment.

Independent performance and financial audits were reviewed by the committee.

Some committee members requested a committee budget to obtain own legal counsel to advise the committee. The committee was not provided a budget, however, Board of Education offered second legal opinion and district legal bond counsel to advise them.

Committee was added to the district's liability insurance policy as an additional insured body.

The Committee has also been invited to some Town Hall meetings, Board Study Session meetings and regular Board meetings when Measure O Bond projects have been discussed.

#### Committee Findings

Projects in Group B were in construction and Group C projects will be ready to bid next year. Our review of published data continued to provide a comprehensive description of project scopes and expenditures.

As required by Prop. 39, the Committee also received and reviewed copies of the District's annual independent performance audit and annual independent financial audit prior to March 31 as indicated in the CBOC bylaws.

The Committee found that, on a 4-3 vote that the expenditures or monies on the expanded projects list were appropriate based upon all the information presented in its review of Measure O expenditures, that such funds

were committed to eligible Measure O projects and were not allocated or expended for any teacher or administrative salaries or other school operating expenses.

The committee on a 4-3 vote decided not to adopt the changes to the bylaws as recommended by the Ad Hoc bylaws committee.

One committee member was an employee of RUSD and voluntarily resigned from the committee.

The committee raised concern regarding using Measure O dollars for consultants versus construction. Although an allowable expenditure, the district and committee agreed to use another funding source for these types of services.

The committee also received correspondence and public comments related to concerns with Measure O funding allocation. Additionally, committee and community members have raised concerns regarding possible discrepancies in the scope of responsibilities of the committee. These concerns will continue to be discussed by the committee as brought forth in public comment.

A motion was made by Jason Hunter to appoint Letitia Pepper as the CBOC independent legal counsel. A substitute motion by Tom Evans was made to reaffirm George Frahm's determination that Jason Hunter's motion was inappropriate and outside the committee's jurisdiction.

The Committee has determined that these funds are being judiciously used and recommends that RUSD continue with funding accountability procedures.
