All bids must be on the forms furnished, all blank spaces filled, and signed with the name and address of the Bidder. No unqualified bids will be read.

Each bid shall be accompanied by a certified check, cashier's check, or a bidder's bond, (executed by a qualified surety company with the power to do business in the State of Idaho) in the sum of not less than five percent, (5%) of the total bid, made payable to School District No. 25, Bannock County, Pocatello, Idaho. This surety shall be forfeited by the bidder in the event of failure to enter into a contract. <u>Personal or company checks will not be accepted</u>.

The Board of Trustees reserves the right to reject any or all bids or to waive any informalities, or to accept the bid or bids deemed best for Pocatello/Chubbuck School District No. 25, Bannock County, Pocatello, Idaho.

#### **INSTRUCTIONS TO BIDDERS**

#### **GENERAL CONDITIONS:**

Bids will be accepted for approximately 50,000 gallons of non-lead gasoline and approximately 120,000 gallons of Red-Dyed Ultra-Low Sulfur Diesel Fuel. The bidder shall supply complete specifications of the fuel he intends to furnish. Said specifications shall show the high and the low octane rating, sulfur and other impurity content, and such other information as to clearly define the quality of the fuel. The bid price shall exclude Federal Excise Tax and State Tax.

The term of this contract shall start August 1, 2025 and renew for additional consecutive years at the same profit margin as established in the bid award or until the District opens a formal bid for a new contract.

Fuel shall be delivered to 3115 Pole Line Road, Pocatello, Idaho.

All bids shall be in a sealed envelope addressed to the Board of Trustees of Pocatello/Chubbuck School District No. 25, 3115 Pole Line Road, Pocatello, Idaho 83201. The following shall be written on the exterior of the envelope:

### BID FOR SUPPLYING GASOLINE AND DIESEL FUEL TO BE OPENED July 1, 2025, AT 9:30 AM

Bids not delivered by vendors at the time of bid opening must be received in mail no later than 4:00 PM on June 30, 2025, the nearest work day prior to bid opening.

No proposal will be accepted unless accompanied by a Certified Check or Bid Bond for not less than five percent (5%) of the total amount bid, as a guarantee, which is to be forfeited in case the successful bidder fails, neglects, or refuses to either enter into a contract or execute bonds for the faithful performance of the contract, or furnish a performance bond. <u>PERSONAL OR</u> <u>COMPANY CHECKS WILL NOT BE ACCEPTED.</u>

Bids must be supplied on the attached Bid Proposal Forms.

#### **REQUIREMENTS OF THE AWARDED BIDDER**

Railcar transported fuel will not be accepted.

Unleaded gasoline must have a minimum 85 octane rating.

The Vendor must produce documentation of the price paid for fuel at the terminal for each delivery to the district so verification of the quoted fixed profit margin can be verified.

During the period of November 1st through March 15th, or as necessary, the red-dyed diesel fuel shall be blended for winter use at or below 20F degrees below zero.

Deliveries shall be made within one day after the District places an order for fuel.

The District may renew the contract for consecutive years at the same profit margin as established in the bid award or until the District opens a formal bid for a new contract.

## **EVALUATION CRITERIA**

Vendor Selection on this project will be based on the following:

1) Price

2) Vendor reputation for providing quality service and reliable delivery. If Pocatello/Chubbuck School District No. 25 has not done business with your company in the past 5 years, please reference 5 current customers you have worked with in the past 2 years.

3) Vendor who best meets the specifications as listed will be given priority in final selection.
