## **PRIMARY FUNCTION:**

The position of Adaptive Physical Education Teacher, under the supervision of the Director of Special Education and/or designee, will provide instruction for students with identified motor needs that cannot be adequately met in a general Physical Education program; will identify students through appropriate assessments and evaluation of motor skills; will perform other related duties as assigned.

## **AREAS OF RESPONSIBILITY:**

- Teaches knowledge and skills in physical fitness, health education, rhythms and dance, and individual, dual, or team sports in accordance with the students' Individualized Education Plan (IEP).
- Participates in the IEP process from referral to implementation as required, including the implementation, preparation, participation and reporting of assessments, report writing, IEP meetings, and development of goals and objectives.
- Maintain current knowledge of regulations, procedures and curriculum needs related to Adaptive Physical Education program needs and services for special education students in both elementary and secondary levels.
- Analyzes, demonstrates, and explains basic skills, knowledge, and strategies of sports, games, rhythms, and fundamentals of body movement.
- Utilizes a variety of instructional skills and methods; vary instructional modes to accommodate student needs, interests, learning style, and ability levels; provide individualized and small group instruction in order to adapt the curriculum to the needs of each student.
- Maintain appropriate behavior management control; show respect for students and their ideas; counsel with students displaying inappropriate behavior or performance; encourage and motivate students towards the successful participation and completion of learning tasks; regularly and consistently report

- student behavior to assigned teachers, administrators and parents.
- Provides appropriate safety instruction and makes safety checks on equipment and field areas to ensure the over-all safety of students; monitors and supervises students while utilizing equipment and field areas to ensure their safety.
- Selects and recommends requisitions for equipment and instructional supplies; maintains required inventory records; maintains surveillance over storage and use of equipment and supplies to provide an orderly, productive environment in the physical education areas.
- Assess each student's progress in physical fitness, skills and knowledge; prepare, document and communicate progress reports to assigned teacher, students, parents, school site and District administrators.
- Identifies pupil needs, and cooperates with staff members in assessing and helping pupils solve health, attitude, and learning problems; cooperate with other members of the staff in planning co-curricular activities.
- May teach under flexible scheduling plans.
- Maintain cooperative, professional attitudes with students, peers, supervisors and parents.
- Perform basic student attendance and program service accounting; maintain and submit upon request, accurate, complete, and correct records as required by law, District policy, and administrative regulations.
- May plan and coordinate the work of aides, teacher assistants, or other paraprofessionals.
- Attend and participate in site, department, and District meetings as assigned.
- Provide for professional growth through creation of and participation in an ongoing program of reading, workshops, seminars, conferences, and/or advanced course work at institutions of higher learning.
- Other duties as assigned.

- Child guidance principles and practices.
- Applicable sections of the State Education Code, District Policies and other applicable laws.
- Current trends and research concerning the growth and development of children.
- Federal, State and District Special Education assessment requirements.

- Work independently with little direction.
- Create an instructional program and a class environment favorable to learning and personal growth.
