CLASS TITLE: OCCUPATIONAL THERAPY ASSISTANT (Range 30)

## **BASIC FUNCTION:**

Under the direction of the School Occupational Therapist, provides occupational therapy services to special education students in accordance with Individualized Education Program (IEP) objectives; assists in the case management of services to students; maintains records and documentation on students; and performs related duties as required.

### **REPRESENTATIVE DUTIES:**

Provide occupational therapy services according to Individualized Education Program (IEP) goals developed by the School Occupational Therapist in accordance with district policies and procedures. *E* 

Assist School Occupational Therapist in assessing student's physical abilities. E

Gather data in the educational environment in such areas as oral motor skills, sensory integration, motor planning, developmental function, self-care and fine motor function. *E* 

Assist with the development of services, the adaptation of the school classroom environment and school materials to improve student functions. E

Attend IEP meetings held for a student and report findings and recommendations, as approved by the School Occupational Therapist. E

Provide assistance to educational staff through consultation, training and direct individual and group therapy. E

Monitor the use of adaptive equipment. E

Document therapy received and record progress. E

Assist with staff development as instructed. E

Individually or with the assistance of other staff members, lift and position student(s) in and out of wheelchairs, braces and/or other orthopedic equipment. E

Travel from school to school. **E** 

Attend to students' personal needs, i.e., bathrooming. E

Organize therapy materials as needed. E

Perform other duties as assigned
