Phase 2-5

Addendum to MOU

The following items will be folded into the MOU dated 10/5/2020.

RSP Teachers (Site Assigned)

- On days with scheduled IEPs, RSP teachers may work remotely.
- Sites will provide RSP teachers and their Instructional Assistants with headsets.
 ***RSP teacher assignment is unique from other in person teacher positions since they serve students across hybrid and virtual programs.

Counselor Duties

- The team recognizes the critical role school counselors play in the social/emotional and academic development of students. For this reason, they will not be assigned to duties outside of addressing student's social/emotional and academic needs, such as temperature checks and supervision.
- On the days there are no students on campus, school counselors will have the opportunity to work remotely.
- School counselors will be able to leave campus after dismissing their students and work remotely for the remainder of the contractual day. This can not impact or interfere with their ability to attend virtual meetings such as but not limited to IEPs, Staff, Department, etc. Employees must be accessible to parents, administration and able to fulfill their duties during their work day.

APE Teachers

- During Phases 2 and 3 all APE teachers will continue to work virtually, and their job responsibilities will be able to be performed remotely.
- APE teachers will use their professional judgment and collaborate with the classroom to adjust their schedules to ensure instruction does not interfere with in-person class time.

Special Education Assessments

- Assessors will have access to a variety of virtual assessment tools including Presence Learning Platform, Q-Library & SANDI. All assessment materials are to be used at the professional discretion of the provider.
- Virtual Assessment tools are not to be utilized prior to competition of training.
- It is at the discretion of the provider to determine if a virtual or in-person assessment is to be utilized. In-person assessments can begin while the district is still in Distance Learning mode. If a provider elects to do an in-person assessment, the In-Person Assessment Procedures must be utilized.

All components of the current Collective Bargaining Agreement (CBA) between RCTA and RUSD not addressed by the terms of this agreement shall remain in full effect.

This agreement is non-precedent setting.

It is agreed and understood this agreement is subject to RCTA review and the approval of the Board of Education.

This MOU shall expire on May 28, 2021.

Early Impact Infant/Toddler Care at Lincoln High School Return to In-Person Attendance at the School Site

Phases 3 and 4 - 4 days a week

- The Early Impact Program at Lincoln High School utilizes three different funding sources including district Title I. The Riverside County Office of Education also partners with the district to apply California General Care Care and Development (CCTR) and Early Head Start Child Care Partnership funding. All state and federal rules and regulations must be followed.
- The infant class will have no more than 8 children in the in-person classroom.
- The toddler class will have no more than 8 children in the in-person classroom.
- Each child will attend the program 4 days a week.

- The same drop off and pick up procedures outlined above for Head Start and State Preschool will be followed.
- Meals/bottles will be given during class time.
- The infants and toddlers will not be wearing face coverings.
- Additional PPE will be provided to the Early Impact Program staff.
- All applicable guidelines outlined in the Riverside Unified School District 2020-2021 In-Person Attendance Guide will be followed.
