## MEMORANDUM OF UNDERSTANDING BETWEEN

  District Business. The one time monthly compensation, which will
  be for June 2020 (\$40.00) and July 2020 (\$40.00) will be added to
  their monthly pay warrant for those specified months.
- This Memorandum of Understanding shall not be precedent setting nor form any basis for a past practice.
