COMMITTEE REPORTS -

Finance Committee meeting - Mr. Jack Evans - Wednesday, March 1, 2016

- Mr. Heiskell presented the committee with a preliminary budget update. Mr. Heiskell and Superintendent Reiley committed to continuing an investigation into the line item budget to see what further reductions were available. Budgets for the schools have been completed with little room for savings. Mr. Heiskell pointed out that Benefits cost have risen from 9.5 to 12% and PSERS Retirement costs are up from 29.2 to 30.03 %.
- Delaware County Intermediate Unit costs are up 31k.
- Operating costs for the DCTS are up 86k.
- There is a reduction of 62k in Special Ed.
- Mr. Heiskell also provided a summary of Committed Fund Balance Major Projects, pointing out that some have been completed, some are ongoing and with the projected shortfall, others may have to be deferred.
- Mr. Heiskell also provided Financial Statements current as of February 29, 2016.
- The Finance Committee agreed that every continuing effort should be undertaken to find additional reductions and that the Board would not pursue an increase higher than the State allowed index. Mr. McGarvey also requested that a copy of the "Line item" Budget be provided to the Board Directors.
- There was again discussion from the other Board members regarding the PA State contribution, early retirement savings opportunities and the deferral of some capital projects.
- Board members also asked if proposed expenditures can be broken out to show which are fixed costs and which may be negotiable.
- There were questions from Board members regarding Technology costs and concerns over whether any department had overspent their approved budget.

GBO Committee meeting - Mr. Paul Eckert - Wednesday, March 1, 2016

- Presentation on the Johnson Control Project, Phase 3 for the Administration Building/Kindergarten Academy. Mechanical Upgrade of the buildings to include- HVAC, Controls, Duct Work, and air quality improvement. The systems are old and are due for an upgrade, this will add life to the buildings.
 - Summary of previous phases.
 - Preliminary Overview of Glenolden, Phase 4.
- Presentation by R.W. Baird for financing of Phase 3 and will add significant money to the budget.
 - o Energy savings and maintenance costs will drop.
- Short discussion on the High School Signage which we will be holding off on until after the budget process. Will re-examine the project at a later date.

Legislative Update – Mr. Mike Burns – Wednesday, March 9, 2016

- Senate passed \$30 billion budget bill. 31-18 vote.
 - Wolf most likely to veto.
 - Senate tends to have the bigger budget bill compared to the conservative House budget bill in terms of spending.
- March 9th and 10th, 2016 Pennsylvania School Board Association filed an application for special relief in the Commonwealth Court for:
 - States to pay Districts immediately for funds that were anticipated for disbursement on February 25, 2016.
 - Two cases on-going.
