REGULAR MEETING MINUTES

I. CALL TO ORDER AND PLEDGE OF ALLEGIANCE

The Board of Selectmen (BOS) meeting was called to order at 6:34 p.m. The Pledge of Allegiance was recited.

Chief Smith apologized for not submitting the monthly report, noting that the EVFD has been very busy. He shared that they have had to respond to two or three more calls on Green Road over the past month, putting out fires. There was a recent crash there as well, and the area is becoming more out of control. There has to be a discussion to come up with possible solutions to rectify the issue.

He shared that, due to the unexpected loss of the ride vendor, this year's carnival has been cancelled, though they are still in discussions regarding the parade. The EVFD's goal is to have a ride vendor contract in place early for next year.
