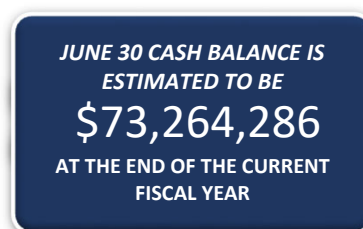
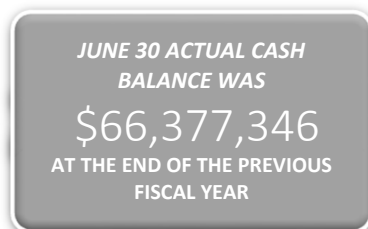
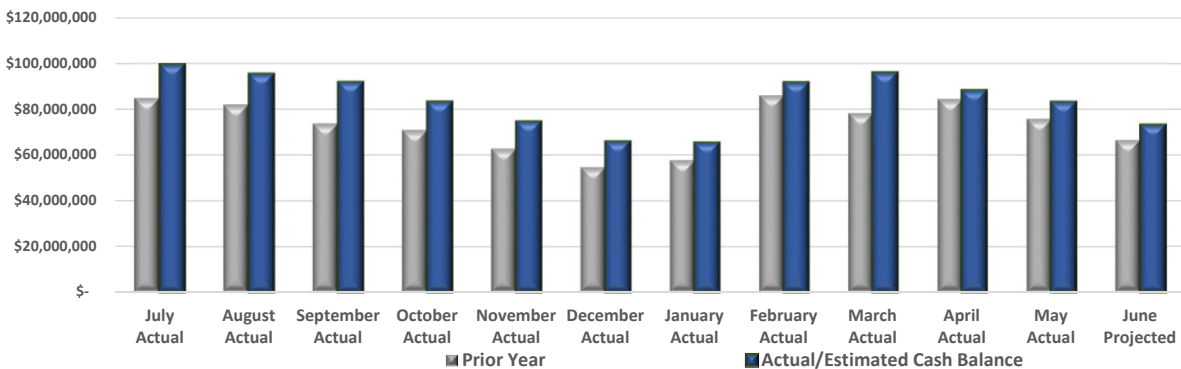
1. YEAR-TO-DATE ACTUALS COMPARED TO PREVIOUS YEAR

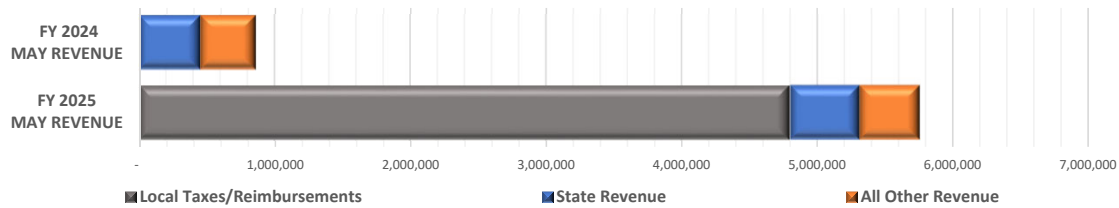

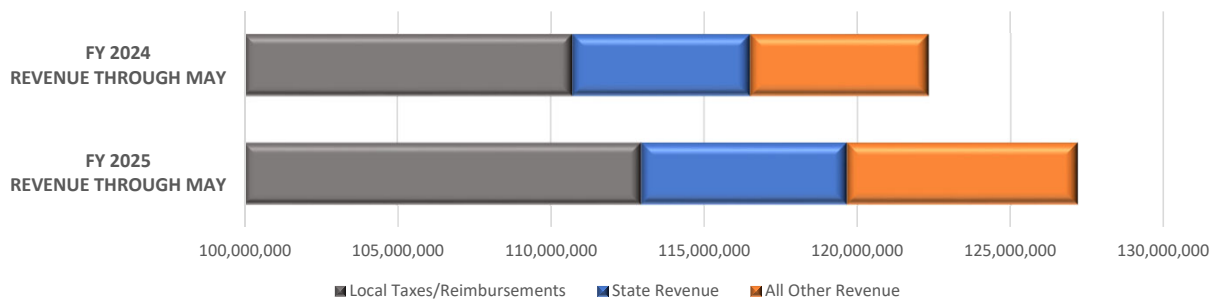

Revenue through May totaled \$127,188,678, which is \$4,856,213 or 4% higher than the amount collected last year. Through May, the largest categorical variances when compared to last year, are: real estate taxes higher by \$2,289,333, and investment earnings higher by \$930,427.

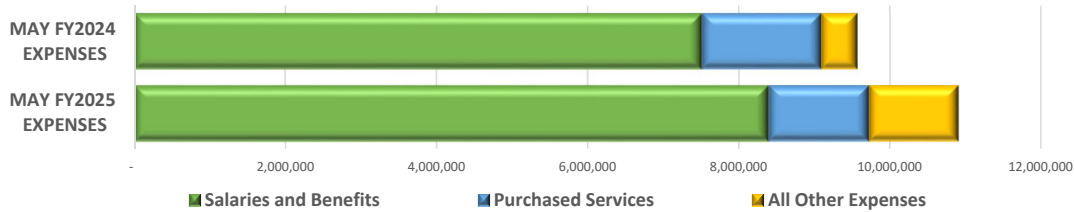

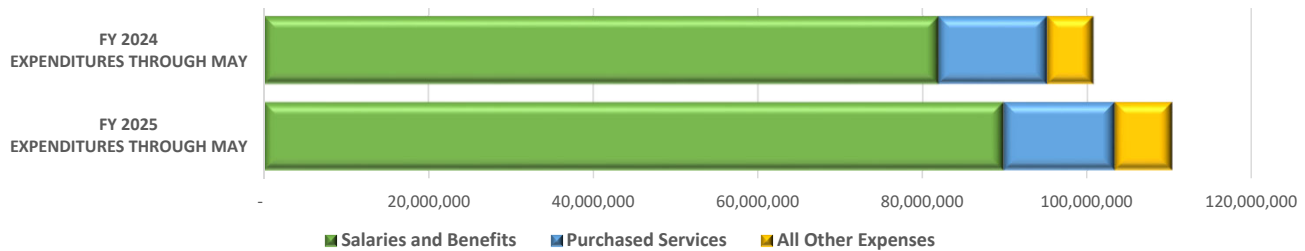

Fiscal year-to-date General Fund expenses totaled \$110,291,249 through May, which is \$9,525,882 or 9.5% higher than the amount expended last year. Through May, the largest categorical variances when compared to last year, are: certified regular salaries higher by \$4,393,521, and retirement higher by \$1,373,182.
